

BOROUGH OF FAIR HAVEN PLANNING BOARD
Regular Meeting Minutes – September 19, 2023

The meeting was called to order at 7:30 pm by the Chairman, Mr. Rolff, with a reading of the Open Public Meetings Act statement (see attached) and salute to the flag.

Roll Call:

Mr. Rolff opened the meeting and asked that the *Administrative Items* on the agenda be addressed.

Mr. Paolo, Vice Chairman, introduced the first agenda item: *Approval of minutes from June 20, 2023 meeting*. Mr. Paolo asked if the Board had any comments on the draft minutes. There were no comments from the Board.

MOTION by Mr. Paolo and second by Ms. Koch to approve the minutes from the June 20, 2023 meeting.

Mr. Rolff asked for members interested in participating in the Environmental Roundtable on September 27th. Mr. Paolo volunteered to represent the Planning Board and Mr. Anderson said he would be the alternate.

Mr. Rolff introduced the next agenda item from *New Business: Consideration of New Land Use Ordinance 2023-12 Amending Ordinance No. 2022-07 Creating a Habitat Rezoning Ordinance*.

Mr. Kovats reviewed the history of the ordinance. He mentioned the review memo created by Heyer Gruel and Associates dated September 14, 2023.

Mr. Bordelon noted that Ordinance 2023-12 allows exemption from the Tree Ordinance. Ms. Koch noted that the Garden Clubs of Fair Haven, Rumson, and Little Silver will be landscaping the property.

The meeting was opened to the public. There were no comments from the public.

Mr. Olson requested that for the next meeting the Board discuss the Environmental Commission's Model Green Checklist.

Mr. Kovats explained that a checklist would need to go before the Council to amend an ordinance. Mr. Olson would like to discuss the checklist to make a recommendation to Council.

Mr. Olson asked that the checklist be discussed in November and would forward the document to the Board secretary.

The meeting was opened to the public. There were no comments from the public.

MOTION to adjourn was made by Mr. Rolff that was carried by voice vote. The meeting was adjourned at 7:50 pm.
