## Important Message from the Mayor

### ***Dear Fair Haven Residents:***

I understand and appreciate the public's right to remain updated on what their elected officials are contemplating, particularly when it involves spending tax dollars and the delivery of public services. However, whenever you hear people talking about what the Borough's elected officials may have done, or are even considering, please keep in mind that there is a big difference between thoughtful deliberation based on facts and wild speculation based on hearsay. Over the next few months, I am asking you to avoid listening to rumors and speculation on what may, or may not, be happening with our Borough facilities. As public stakeholders, I am asking you to become part of an informed discussion on how best to upgrade our aging facilities, so that they can meet the needs of Fair Haven for the next fifty years.

The following question and answer segment is a follow-up to my prior public statements regarding the Borough's ongoing facilities upgrade review. The impetus to move forward with this review came out of many committee level and public discussions that have taken place over the past three years, which focused on the state of our Borough's facilities.

***Is the Borough considering purchasing the abandoned Sunoco Property on River Road?*** Yes, the property has been abandoned for nearly ten years and it is a blight on our downtown. The Sunoco site is being considered as a potential location for a new police station and Borough Hall, but the final and best location for both these facilities is still under review and deliberation. Historically, the Borough also purchased the former Masonic Temple on River Road, worked out a developer's agreement to provide some very much needed public parking in the eastern portion of our business district and then subsequently sold the property, which now is home to two thriving businesses.

***Was the recent public hearing for the removal of the Police Station/Community Center from the Borough's Recreation and Open Space Inventory (ROSI) related to the facilities upgrade project?*** Not really, the fact is that while considering renovations to those buildings, we discovered that both the buildings and the park area were listed on our tax map as one block and lot, which is why the developed portion was originally and mistakenly placed on the ROSI. Since the buildings and the parking lot area were not open space at the time the Borough was required to submit our ROSI to the State; we are simply correcting a historical error.

***Is the Borough looking to build a Parks Maintenance Facility in Fair Haven Fields?*** That is only a possibility, which is under consideration as part of the plan to replace our present Department of Public Works building. The overall goal is to come up with a plan that delivers services in the most efficient and cost effective manner. Our architect is presently working on two concept plans for our Public Works Facility. One of the options does include a small two bay garage to be located within Fair Haven Fields, which will only store equipment used to maintain those 73 acres. That building could also include additional public restrooms and parking. The other option will not include a garage at Fair Haven Fields and we will continue to store all equipment at the main DPW building. It is important to note that both options will reduce the total footprint of the present facility, which is located in a residential neighborhood. Most importantly, it is a fact that the Borough cannot build a parks maintenance facility in Fair Haven Fields without first getting approval from both NJDEP and Monmouth County. That approval process would require the Borough to give full public notice and hold a public hearing; as such, our residents will have ample opportunity to give their input on whether they want to dedicate a small area of the park to such a building.

***Did the Borough consider renovating and/or building a new police station and community center in the present location?*** Yes, renovation of the site was explored, including concept plans and cost estimates. However, renovation was very expensive and it would still result in facilities that had safety, space, location, inadequate parking and ADA compliance issues. Once again, our present police facility is located within a residential neighborhood, which is less than ideal. Building a new facility in that location is still being actively considered as part of the overall facilities review. The final decision will depend on many factors, including whether the Sunoco site is available and appropriate, as well as the total cost for all options.

***When will the public be able to review and weigh in on the various options for Borough facilities?*** The Borough's architect is working on general draft concept plans for the DPW facility, the Police Department and the Community Center. Those concept plans will be presented at a public meeting solely dedicated to that single topic, which will be widely advertised. **That meeting is scheduled for January 10, 2019 @ 7:00 p.m. in the Knollwood School All Purpose Room.** We are waiting until January for two reasons: first, the architect needs sufficient time to draft the plans; second and most important, we do not want to hold a meeting and/or meetings on this important topic during the holiday season, because we know our residents are busy and may not be able to attend this important meeting.

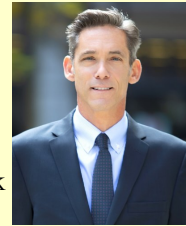

## *From our Borough Administrator . . .*

### **Bulk Disposal Service Upgrade Announcement**

On behalf of the Mayor and Council, I am very pleased to announce that, beginning in January, 2019, the Borough will be replacing our bulk drop off program with a curbside bulk pickup program. The Governing Body is making this change as part of an ongoing effort to increase services to our residents.

Fair Haven residents will no longer have to load up their vehicles with bulk trash and bring it to our Department of Public Works facility. Instead, once a month, from January through October, residents can simply place bulk trash items at their curbside and they will be picked up at no charge.

#### **2019 CURBSIDE BULK PICK UP SCHEDULE**

Trash Zones 1 & 2 will have bulk pickup on the first Monday of the month, from January through October. Trash Zones 3 & 4 will have bulk trash pickup on the second Monday of the month, from January through October.

#### **PLEASE FOLLOW THESE VERY IMPORTANT GUIDELINES:**

- All bulk items shall be placed behind the curb or edge of pavement and not in the street.
- Appliance disposal will require prior scheduling through the main office (732-747-0241, ext.\*219). There will be a \$15.00 fee for the appliance disposal sticker, which must be placed on the appliance. Refrigerator doors and large coolers must have the door or lid removed when placed at the curb.
- E-waste disposal (TV, Computers, Game Stations, etc.) will require prior scheduling through the main office (732-747-0241, ext.\*219). E-waste items must be separate from other bulk items and please place smaller E-waste items in a separate container.
- No trash bags will be accepted for bulk pick up.
- All metal items must be placed in a separate pile.
- Bulk pick up will be limited to what, in the opinion of the Director of Public Works, is a reasonable amount of bulk, not to exceed what would fit into a small pickup truck. There will be no full basement cleanouts or whole house move outs.
- No construction debris will be picked up, including: cabinets, flooring, plumbing fixtures, drywall, yard fencing or large swing sets.
- There will not be a bulk pick up during November and December as our DPW crews are dedicated to extensive leaf collection

### NO KNOCK Registration Ordinance.



There is a NO KNOCK Registration Ordinance in effect which allows you to register with my office to be placed on a NO KNOCK list so solicitors will not approach your home, if you choose. When an applicant applies for such a license and if they are approved, they will be given a copy of the list (address only) of those who have registered. Hours have also been set for solicitation from 10:00 a.m. until 6:00 p.m. Please keep in mind that there are organizations that are federally exempt from state and local regulations and can approach your home at hours other than what has been set. I will also be providing exempt organizations with the list of NO KNOCK registrants and ask for consideration. If you have already registered your property, you do not need to re-register.



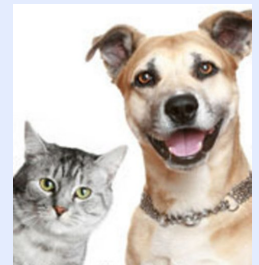

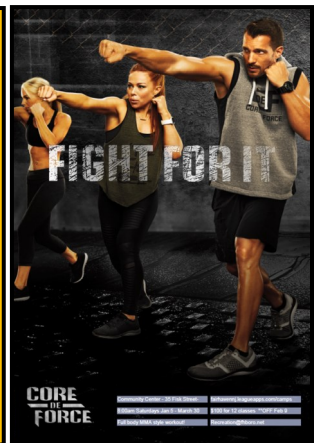

## Snow and Ice Removal from Vehicles and Sidewalks

### **N.J.S.A. 39:4-77.1a – Failure to Remove Snow/Ice from Motor Vehicle**

Each driver of a motor vehicle operated on a street or highway in this State shall have an affirmative duty to make all reasonable efforts to remove accumulated ice or snow from exposed surfaces of the motor vehicle prior to operation. Surfaces shall include, but not be limited to, the hood, trunk, windshield, windows, roof of the motor vehicle, the cab of a truck, the top of a trailer or semitrailer being drawn by a motor vehicle and the top of an intermodal freight container being carried by an intermodal chassis. A person who violates the provisions of this subsection may be stopped on a street or highway by a law enforcement officer who believes the accumulated ice or snow may pose a threat to persons or property regardless of whether any snow or ice is dislodged from the motor vehicle.

### **Borough Code 14-6.1—Snow and Ice Removal Required; Time Limit.**

The owner, tenant or occupant of any building or lands abutting upon any street within the Borough of Fair Haven shall cause the sidewalk in front of the property to be cleared of snow or ice to a width of at least two (2) feet within twenty-four (24) hours after the cessation of the snowfall or formation of ice. In case of ice on the sidewalk, should it be impracticable to remove same, then the sidewalk shall be covered with sand or some other suitable substance so as to cause the sidewalk to be made safe and convenient for persons traveling thereon.

Remember not to leave your vehicles in the street if there is a chance that it may snow. Also, if you have a corner property, it is your responsibility to shovel the sidewalk in front of your residence and on the side.

## Special Needs Registry

In April 2016, the Monmouth County Special Needs Registry website began accepting new registrants. The goal of the registry is to ensure all Monmouth County residents who have special needs are able to get the help and support they need in a time of emergency or during interaction with Law Enforcement, Fire or EMS personnel. It is open to any person who has a physical or mental impairment that substantially limits one or more major life activities due to a physical and/or intellectual disability.
