FAIR HAVEN BOROUGH COUNCIL MAY 8, 2017

The meeting was called to order by Mayor Lucarelli at 7:02 p.m. The Flag Salute was followed by a Moment of Silent Meditation. Mayor Lucarelli read the Sunshine Law Statement.

ROLL CALL

On Roll Call the following were present: Councilmembers Marchese, Peters, Rodriguez, Sorensen and Wilhelm. Absent: Councilman Jaeger. Others present: Administrator Casagrande and Attorney Alfieri.

PROCLAMATION

Mayor Lucarelli read a proclamation for National Safe Boating Week (May 21st through 27th).

WORKSHOP SESSION

Mayor Lucarelli said that the Fair Haven Business Association has requested permission to post 10 lawn signs from May 11th -20th for their annual sidewalk sale which will occur May 19th and 20th. Motion to approve moved by Councilman Peters, second by Councilman Marchese with Ayes by all present.

The next order of business was the discussion on the possible amendment of Code 30:7-8 (Accessory Buildings and Structures). A draft ordinance was included in the governing body's packet. This matter has been listed on the past few agendas. The last sentence of subsection H is to be changed by striking it; this is the best way to handle as porches are permitted. Councilman Peters was in disagreement with going with the original amendment; he wanted to discuss further and asked that it be carried to the next agenda. Mayor Lucarelli asked if there was any other language desired for inclusion. Councilman Peters said that we should allow 20% of the area to be steps. Councilman Marchese said that we need to go back to the starting point to remove the language as a short term solution. The glaring example is in the current code and the amendment to remove the language will address the issue, short term. Attorney Alfieri said that there are so many unintended consequences with land use ordinances in any municipal code. We can limit the encroachment to the front yard. It was asked if this matter could be tabled to the May 22nd meeting to come up with language that would give the Planning Board flexibility. Councilman Peters said that three steps maximum was the last discussion to which Councilman Marchese agreed and stated that this would be in compliance with the Building Code. Attorney Alfieri clarified what the governing body was looking for to create the amendment and run it past engineering before it is listed on an agenda.

Mayor Lucarelli introduced Kerry Pflugh, NJDEP, who was in attendance. Ms. Pflugh introduced herself and handed out her business card to the governing body. She thanked the Mayor for giving her time to speak. She is visiting all NJ municipalities and talking to the administration about the services that the NJDEP provides. She sends daily e-mails with programs, news, etc.

Administrator Casagrande advised the governing body that there will be a resolution on the May 22nd agenda appointing the 2017 Rec N Crew Summer Camp staff. Most of the list is Junior Counselors who are paid \$8.00 per hour. The two Supervisors (school teachers) receive \$17.00 per hour and we have three Assistant Camp Counselors (second in command) who received \$8.75 in the past and DJ Breckenridge, Parks and Recreation Director, would like to bump the Junior Counselors up to \$10 per hour. Administrator Casagrande concurs with this request and the pay is commensurate with their responsibilities. The bump equates for \$109.50 each for the season. The camp fees were increased by \$10; an additional \$2,000 revenue is projected.

Administrator Casagrande reviewed the Capital Ordinance listed later in the agenda and two Chapter 159 resolutions on the agenda as well.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:20 p.m. Susan O'Brien, River Road, questioned the Payroll Agency payments on the bill list. Administrator Casagrande said that they are not public funds, they are taken out of the employee paychecks and we pay the fees (i.e. life insurance, AFLAC, etc). Colleen Lapp, CFO, wants them to be reported on so they will be included on all of the bill lists.

There being no further comments or questions, the meeting was closed to the public at 7:21 p.m.

AN ORDINANCE PROVIDING FOR THE ACQUISITION OF VARIOUS EQUIPMENT, INFRASTRUCTURE IMPROVEMENTS AND IMPROVEMENTS TO PUBLIC BUILDINGS AND GROUNDS AND APPROPRIATING THE SUM OF \$215,000.00 THEREFORE, AUTHORIZED IN AND BY THE BOROUGH OF FAIR HAVEN, IN THE COUNTY OF MONMOUTH, NEW JERSEY

WHEREAS, the Borough of Fair Haven, in the County of Monmouth, New Jersey has determined to acquire various equipment, make improvements to infrastructure and public buildings and grounds; and

WHEREAS, the Borough of Fair Haven has \$215,000.00 in the Capital Improvement Fund.

NOW THEREFORE, BE IT ORDAINED and enacted by the Mayor and Council of the Borough of Fair Haven, County of Monmouth, New Jersey, that:

SECTION 1. The purchase and/or procurement of services described in Section 2 of this ordinance is hereby authorized as a General Capital authorization to be undertaken in and by the Borough of Fair Haven, County of Monmouth, New Jersey.

SECTION 2. The acquisitions and improvements hereby authorized to be undertaken consist of:

- a. Any capital equipment, so determined as to be necessary
- b. Roadway and Infrastructure Improvements, so determined as to be necessary
- c. Buildings and Grounds Improvements, so determined as to be necessary
- d. Information technology hardware and software, so determined to be necessary

together with all items necessary, incidental or appurtenant thereto.

SECTION 3. The 2017 General Capital Budget of the Borough of Fair Haven is hereby amended to conform to the provisions of this ordinance.

SECTION 4. All ordinances or parts of ordinances inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 5. This ordinance shall take effect 10 days after the first publication thereof after final adoption, as provided by law.
