FAIR HAVEN BOROUGH COUNCIL MAY 22, 2017

The meeting was called to order by Mayor Lucarelli at 7:00 p.m. The Flag Salute was followed by a Moment of Silent Meditation in memory of Phil Binaco, long time fireman and father to Dave Binaco, former Fair Haven Police Officer. Mayor Lucarelli read the Sunshine Law Statement.

ROLL CALL

On Roll Call the following were present: Councilmembers Jaeger, Marchese, Peters, Sorensen and Wilhelm. Absent: Councilman Rodriguez. Others present: Administrator Casagrande and Attorney Alfieri.

OATH OF OFFICE

Police Chief, Joseph McGovern, welcomed family and friends and acknowledged former Police Chief, Darryl Breckenridge. Mayor and Council and all who participated in the promotion process were thanked. He gave Stephen Schneider's work history beginning in 2006 and that he has been Detective for about 5 years and will do a great job as Police Sergeant.

Mayor Lucarelli administered the Oath of Office to Stephen Schneider for the position of Police Sergeant. The Bible was held by Stephen's wife, Allison.

Stephen Schneider thanked everyone for coming. Fair Haven is a fantastic town and the police department has the best men and women to work with from the Specials to the Chief. He thanked Darryl Breckenridge for hiring him from Brookdale without knowing much about Fair Haven and he thanked Chief McGovern for allowing him to move forward with his career. He thanked Mayor and Council for the process to make this promotion possible. He asked that his wife, Allison, come forward and stated that she is the person who keeps him grounded.

A five minute recess was taken.

WORKSHOP SESSION

Kieran Tintle, JCP&L, came forward to give a brief presentation on LED lights; he left information with Administrator Casagrande. Council requested a break even cost; Mr. Tintle did not have that information, but will send it. LED lighting has a different color and lasts longer than sodium lighting.

Mayor Lucarelli advised there was a tree removal appeal from Petcon Builders for 56 Laurel Drive; photos were distributed. Motion to approve moved by Councilman Wilhelm, second by Councilman Jaeger with Ayes by all present.

Rumson-Fair Haven Rowing has requested permission to post signs in the shape of an oar advertising the Rumson Boat Race. They would like to place them on River Road, Ridge Road, Hance Road, Buena Vista Avenue. The Chief requested they not be placed on street signs or be more than 48" from the ground. Council asked that they come to the next meeting with a sample and that they be advised that the signs cannot be more than 48" high. Motion to table this matter to the June 12th meeting was moved by Councilwoman Sorensen, second by Councilman Marchese with Ayes by all present.

Girls on the Run requested permission to post lawn signs beginning May 23rd for their annual event. Motion to approve moved by Councilman Wilhelm, second by Councilwoman Sorensen with Ayes by all present.

The Mayor received a request from the NJDOT to film in Fair Haven on June 9th. Mayor Lucarelli advised that they would like to film Transition Day on June 9th showing how the children ride from one school to the next. They will also be filming on June 5th and 6th. The film is for promotion and to educate other municipalities. They will be interviewing parents, School Superintendent, Police Chief, etc. Motion to approve the request and waive the fee for commercial filming moved by Councilman Peters, second by Councilman Jaeger with Ayes by all present.

Councilman Rodriguez arrived to the meeting at 7:17 p.m.

There was an updated draft amendment to Code 30-7.8, Accessory Buildings and Structures from Attorney Alfieri; he did not receive a response from Engineer Gardella and Assistant Engineer Poruchynsky. If there is no objection to this ordinance, it could be listed on June 12th for introduction. Todd Lehder, Zoning Board Chairman, introduced himself as well as other Zoning Board members (Peter Neczesny, Betsy Koch, Patricia Quigley, Joe Mule). He said that he does not support the new language as it promotes homes to be closer to the street and also creates taller basements. There will be an aesthetics issue with this amended ordinance which will exacerbate an existing problem. He reviewed certain ordinances with regard to height, setbacks, etc. It seems the

spirit of the ordinance is to make it that residents are able to build front porches especially for existing homes that may not have the square footage in the front of their house without encroaching in the set back. Mr. Lehder supports the concept, but feels that the ordinance should not apply to new construction; they should be built behind the set back. No one has ever said that the setbacks are too tight. The Zoning Board doesn't usually participate in this process, but reviews the ordinance to make determination on applications; they need to proactively manage the ordinances. The ordinance should be drafted in a way that it should apply to previously built and CO'd structures; not new homes. Mr. Lehder mentioned another ordinance regarding garages that needs revision. Attorney Alfieri will redraft the ordinance for further discussion on June 12th. Patricia Quigley asked for a copy of the current ordinance; Attorney Alfieri gave her his copy. Joe Mule' asked if this is for uncovered structures; yes. He said that theoretically this is for a concrete pad and asked why someone would want to do this. Councilman Peters gave the history on the original ordinance and allowing for covered porches. It appears that this amendment does not address porches at all; he gave some examples to include in the amending ordinance. Annual Zoning Board reports are given which shows 90% of the applications are approved. The Board is trying to reach a balance. Attorney Alfieri will give alternate choices for Council to review and discuss at the next Council meeting under workshop. Councilman Wilhelm thanked the members of the Zoning Board for attending and sharing the concerns. Attorney Alfieri will look at the section regarding garages.

With regard to capital project priorities and funding, Administrator Casagrande distributed two spreadsheets to the governing body for consideration. We pass a capital ordinance each year and then act on projects through a purchase authorization. Many of the considerations listed go back a few years. There can be some money refunded to the line item if it comes under budget.

Councilman Wilhelm left the meeting at 7:34 pm and returned at 7:36 pm.

The Capital Ordinance on the budget should be approved tonight by the Mayor and Council for 2017. Administrator Casagrande said we were just advised of a broken pipe at the end of Gillespie Avenue; we are unsure of the cost to repair at this time (the money would have to come out of Capital). With regard to Capital, she met with Councilmembers Peters and Jaeger to review and highlight things that Mayor and Council should consider discussing for funding. She would like an idea of what is to be funded and the priority for the governing body. Councilman Jaeger advised that there is \$300,000 available and recommended spending up to 2/3 of the money and holding 1/3. The governing body discussed various considerations (DeNormandie Pocket Park, McCarter Pond, Schwenker Pond). The Community Center fields will be addressed; Mayor and Council commented about its current state and how good it looks. Bicentennial Hall has punch list items created by the Borough Engineer. Projects need a use and money should not be expended for BIC Hall at this time. It was asked what the minimum is that could be done in order for the building to be used. The Police Department will be taking over the Community Center during repairs/renovations so those who currently use the center will need an alternate place to meet. The exterior items (roof and landscaping) could be held and interior items addressed.

Councilman Wilhelm left the meeting at 7:52 pm and returned at 7:54 pm.

Mayor Lucarelli gave a history of the church. It is a museum piece that we have done work on as it is historically significant to the Borough. The hope and plan was to fix the building and allow usage by organizations, etc. or for private affairs. It has not been used for the past ten years while improvements have been made. Councilwoman Sorensen suggested reaching out the Historical Society to see if they would be willing to fundraise toward these improvements. Administrator Casagrande advised that some groups have reached out to use BIC Hall. Councilman Jaeger said that someone needs to take ownership of the building. Councilwoman Sorensen made a motion that the Recreation Committee will take ownership, second by Councilman Jaeger with Ayes by all present. Mayor Lucarelli directed the Recreation Committee to look at the building, make a decision on what should be done and discuss it with the Borough Engineer. Councilman Peters advised that long term financing was reviewed and we have reduced our net load by \$1 million. The Borough has done major capital improvements and we are looking at a net reduction. Councilman Wilhelm advised that the Scot Air Packs for the Fire Department are vital and a lot of them have aged; it was agreed to fund \$8,000 for the air packs as well as a portion of the computer program update and AEDs. The governing body discussed all of the lists. The Mayor asked that Administrator Casagrande and Engineer Gardella sit down, review the projects to figure out the seasons, costs and bids. McCarter Pond improvements could happen this summer and DeNormandie Avenue may not happen until 2018 (depending on the Littoral Society), as well as Community Center Fields. The governing body agreed to start with fencing at Schwenker's Pond. BIC Hall will be allotted \$34,000 to complete (the Recreation Committee should review). Departments will be addressed as they come forward.

The meeting was opened to the public for comments or questions at 8:08 p.m. Ashley Britain, Red Bank, said that her grandfather built a home in Fair Haven in 1961 and still resides there today. She and her grandparents attend Fisk Chapel and she would like to see improvements. She works for Tesla Community Incubator Space, Rahway, NJ and would like technology to come to Fisk Chapel. She asked the governing body for their support and assistance with promoting the program to bring children and adults in to use their minds and imagination. It will be a fee based program; the workshops will be free to introduce the program. She has tesla coils and devices that children can play with, virtual reality workshops, etc. Permission was obtained from the church and she would like to interface with the Borough. Council suggested she attend the next Recreation meeting and present her idea.

Ruth Blaser, River Road, questioned a payment to Bill Brooks to review trees for the 20 Gillespie Avenue Project. She was advised that it is not a Borough expenditure; the developer is charged for the many times Mr. Brooks has met on-site. She questioned the child support payment listed under payroll. The Chief Financial Officer has changed the bill list a little and child support is paid through payroll. She questioned if the payment to the church for cell tower is a pass through; yes, governing body approval is required to pay bills.

There being no further comments or questions, the meeting was closed to the public at 8:15 p.m.
