**WHEREAS**, the Borough of Fair Haven is the owner and controls the project site.

# NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR OF THE BOROUGH OF FAIR HAVEN THAT:

- 1. Theresa Casagrande, Borough Administrator, is authorized to (a) make an application to the County of Monmouth for Open Space Trust Funds, (b) provide additional application information and furnish such documents as may be required for the Municipal Open Space Grants Program and (c) act as the principal contact person and correspondent of the above named municipality; and
- 2. The Borough of Fair Haven is committed to this project and will provide the balance of funding

necessary to complete the project in the form of non-county matching funds as required in the Policy and Procedures Manual for the Program; and

- 3. If the County of Monmouth determines that the application is complete and in conformance with the Monmouth County Municipal Open Space Program and the Policy and Procedures Manual for the Municipal Grants Program adopted thereto, the municipality is willing to use the approved Open Space Trust Funds in accordance with such policies and procedures, and applicable federal, state, and local government rules, regulations and statutes thereto; and
- 4. Theresa Casagrande, Borough Administrator is hereby authorized to sign and execute any required documents, agreements, and amendments thereto with the County of Monmouth for the approved Open Space Trust Funds; and
- 5. This resolution shall take effect immediately.
