FAIR HAVEN BOROUGH COUNCIL FEBRUARY 13, 2017

The meeting was called to order by Mayor Lucarelli at 7:00 p.m. The Flag Salute was followed by a Moment of Silent Meditation. Mayor Lucarelli read the Sunshine Law Statement.

ROLL CALL

On Roll Call the following were present: Councilmembers Marchese, Peters and Sorensen. Absent: Councilmembers Jaeger and Wilhelm. Others present: Administrator Casagrande and Attorney Alfieri.

PROCLAMATIONS

Joan Jay was unable to attend the meeting due to illness. She will be invited to our February 27^{th} meeting.

The Mayor invited Mr. and Mrs. Frissora to the front of the room and read a proclamation congratulating, their son, Michael, on his Eagle Scout achievement. Mrs. Frissora thanked the Council and directed the public's attention to a picture display showing Michael's project (a garden constructed of nine wooden pallets at Sickles School for educational and practical purposes). She advised that the person who presented and pinned her son was her cousin, John Drake, who grew up in Fair Haven and earned his Eagle Scout award in 1978; he constructed a sign for Bicentennial Hall. Michael could not attend this meeting because he was at school (Stevens Institute).

WORKSHOP SESSION

Mayor Lucarelli advised that Aimee Humphreys resigned her position on Council so the Democratic Party provided a list of three names as a replacement. He thanked Aimee for serving on Council. To be fair, each candidate was invited to speak for five minutes on what being a Councilmember means to them. Patricia Quigley came forward. She advised that she is a former attorney (NJ and NY bar) last practicing in 2012 and currently works at her family's business, Barnacle Bills. She has three kids that are grown and this is a good possibility to give back to the Borough. She has been a resident of Fair Haven since 1984. As an attorney she was Real Estate Counsel for developers in Rumson, practiced small business law, negotiated transactions and created resolutions. She has been involved in zoning, tidelands rights, liquor licenses, DEP, land use matters and was involved with the PNC Arts Center Tax Exemption. Mrs. Quigley said her family has supported local causes such as Clean Ocean Action, Covenant House, 180 Turning Lives Around, Holiday Express and the Rumson St. Patty's Day Parade. Mrs. Quigley said the reasons she would like to serve on Council is that it seems Fair Haven is facing a lot of pressure from the surrounding towns as far as development, there are Department of Public Works issues, education, etc. She stated she was more analytical than in the forefront. She would like to lend her skills and experience (grant writing, breaking matters into small pieces, research, etc) to the Council and would like to show her gratitude to Fair Haven.

Amy Mallet, Democratic Chairperson, read a statement prepared by Shervyn VonHoerl, who had a prior trip planned and could not reschedule. Mr. VonHoerl moved here in 2014 with his wife and three children. He felt that he made the right choice by moving to Fair Haven and enjoys the traditions of the Fireman's Fair, Stokes and transition. He advised that he has a long history of volunteerism such as being Treasurer of a 501C3 organization that is related to Dartmouth College (his alma mater), coaching Fair Haven recreation sports, helping during Trucktoberfest and soon to become Cub Master of Fair Haven Pack 127. He is a Portfolio Manager, by profession, and a portfolio he runs is a Municipal Legacy Fixed Income. Mr. VonHoerl said that he has more he can contribute to Fair Haven. He looks forward to Council's decision in two weeks and felt that any candidate chosen would be an asset.

Christopher Rodriguez came forward and also read a statement. He thanked Council for allowing him to speak. He and his wife live in town with their three children. There are three great candidates offered as a replacement and Council cannot go wrong with whomever they choose. He hopes to serve to benefit his neighbors and children and volunteers his time to keep Fair Haven a great place to live and raise a family. Mr. Rodriguez said, as Councilman, that he will listen, learn and generate new ideas to benefit Fair Haven. He is involved with Scouts (also an Eagle Scout); it has been his lifelong theme to be involved), volunteers for the Fireman's Fair, scarecrow fee collection for the school, Chairman of the Shade Tree Commission, liaison to the Fair Haven Natural Area, worked with the Environmental Commission on some projects (involved with the Green Team Recognition) and coaches soccer. He is formally trained in Finance, obtaining his Masters Degrees from Columbia Business School and also Rutgers University. He is an entrepreneur and started a company along with some institutional backers and built a federally regulated derivative exchange from scratch which resulted from the financial crisis. The focus of his company, Eris Exchange, provides a marketplace for large firms to transfer debt obligation from floating rate risk to fixed rate risk in the most efficient manner possible. Mr. Rodriguez said his financial background can help with the budget, cost benefit analysis and capital projects to positively influence the residents of the community. It is clear that the Council has done many things to reduce costs over the years including shared services, outsourcing and finding other ways where it makes sense to save money. He would like to contribute and explore positive revenue generation products as well as help manage these costs. As a Councilperson, besides

focusing on the Borough's financial health, he would like to put effort into three other key areas: volunteerism, seniors and the environment. He thanked the Council for their time.

Mayor Lucarelli thanked all three candidates for their time and offering their talents. He thanked Amy Mallet for bringing three talented candidates before the Council for consideration.

With regard to the proposed amendment to Chapter 30:7-8(h), Administrator Casagrande explained this eliminates the section with regard to front yard/side yard setbacks. A list of addresses was sent to the Council so they could look at what the concerns were and to make a decision as to the ordinance being amended. Councilman Peters said he visited some of the suggested sites, but not all of the issues have been worked out. It was asked that this be listed on the next meeting agenda for further discussion.

Administrator Casagrande said that as per the January 23rd meeting, she had the Building Department review the proposed amendment to Chapter 30:2-4, defining habitable attic and they suggested we further align the language with the Uniform Construction Code. Attorney Alfieri said he can incorporate the definition of the code. Comments were not received from Engineer Gardella or Assistant Engineer Poruchynsky. The ordinance could be adjusted to add "as defined by the Uniform Construction Code." Councilman Marchese said that other parts of the code will need to be amended where this is involved. An ordinance will be listed for introduction at the February 27th meeting.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:32 p.m. Susan O'Brien, River Road, said that there is a resolution on the agenda to extend the contract with M&S Waste Services for another two years and noted that there are volunteers, for the Natural Area, bringing the can to the street which M&S has not been picking up. She asked that the contract be updated to include that. Administrator Casagrande said that the contract has not been changed. They are picking up the can that is put out by the volunteer; it was an added can since the original contract. Mrs. O'Brien felt that a DPW employee should be bringing the can out to the street. Administrator Casagrande said she has not heard that there is an issue with this from the volunteer. Councilman Peters said that when the Borough was handling trash collection, in-house, it cost \$425,000 and with the M&S Contract extension, it will be almost \$183,000. There has been a major improvement in terms of cost structure (a savings of \$1.4 million to date). Mrs. O'Brien is concerned about the animal waste and pollution in the Navesink River. Mayor Lucarelli said the DPW may step in if the volunteer no longer wishes to continue the task.

Katy Frissora, Lexington Avenue, said that we need to be careful with volunteers. The residents shovel the area around the fire hydrants during snowstorms to keep it clear. Volunteering is big in Fair

Haven and always seems to help. Our residents like to be involved in town.

There being no further comments or questions, the meeting was closed to the public at 7:36 p.m.

6. Resolution No. 2017-42, Authorize Monmouth County Mosquito Control Division to apply pesticides

WHEREAS, the Monmouth County Board of Chosen Freeholders, pursuant to NJSA 26:9-27, et seq., has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitoes within the County; and

WHEREAS, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control and chemical control to exterminate the mosquito population within the County of Monmouth; and

WHEREAS, prior to conducting aerial dispensing operations over a designated "congested area", the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and

WHEREAS, the Borough of Fair Haven is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

NOW THEREFORE BE IT RESOLVED as follows:

- 1. The Mayor and Council of the Borough of Fair Haven hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides, by aircraft, for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard or both with the understanding that:
- a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies; and
- b. Such operations will be performed in compliance with applicable Federal and State regulations; and
- c. The County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.
