FAIR HAVEN BOROUGH COUNCIL MARCH 26, 2018

The meeting was called to order by Mayor Lucarelli at 7:00 p.m. The Flag Salute was followed by a Moment of Silent Meditation. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Councilmembers Koch, Marchese, Peters Rodriguez and Sorensen. Absent: Councilman Jaeger. Others present: Administrator Casagrande and Attorney Alfieri.

WORKSHOP SESSION

Mayor Lucarelli asked for approval of the following street opening applications:

- NJ American Water to retire old water service -174 Buttonwood Drive
- NJ American Water to replace water service 174 Buttonwood Drive
- NJ Natural Gas to install gas service 113 Church Street
- NJ Natural Gas to install gas service 128 Fair Haven Road
- NJ Natural Gas to retire gas service 86 Third Street

Motion to approve moved by Councilman Rodriguez, second by Councilwoman Sorensen with Ayes by all present.

With regard to bulk drop off hours for the town-wide yard sale and 2019 Program Review, Administrator Casagrande advised that the Borough schedules DPW services at the end of the year prior so it can be included in the municipal calendar. This year we have drop offs on the first Saturday of the month and some months have a second drop off date. Councilwoman Koch suggested that the drop off on the day of the town-wide yard sale be changed to 1:00-5:00 p.m. instead of 9:00 a.m. to 1:00 p.m. so people who have left over items can bring it to the Recycling Center instead of holding it until the 3rd Saturday. Administrator Casagrande said that it may be best to hold drop off from 9:00 a.m. until 5:00 p.m. Mayor Lucarelli was concerned that the dumpsters may be filled by the end of the day and suggested ordering a larger container for the May 5th drop off. It was hoped that the two drop off dates in May would help. Councilman Peters felt that there needs to be a more frequent service for bulk. Councilwoman Sorensen suggested extending the bulk drop off hours until 4:00 p.m. the day of bulk drop off. The consensus of Council was for the hours to be 9:00 a.m. until 3:00 p.m. on May 5th. There was brief discussion on DPW overtime for this service.

Administrator Casagrande said that the 2019 Bulk Schedule will be reviewed with the DPW Director and the Committee. The DPW yard is small for this process and not the safest. The Borough is looking for a new facility. She asked for consideration to institute a monthly bulk pick up. Councilwoman Sorensen recommended it be offered quarterly. The fall months would be tough because of leaf and brush pick up as some of the equipment is altered to accommodate for this task. There could be 9 bulk pick-ups in a year to increase this service to the residents. A decision will need to be made by June or July in order to have it incorporated into the municipal calendar. Many towns follow this schedule and have different ways to address it (i.e. a reasonable amount or limit the maximum number of items).

With regard to the proposed Special Event Tipping Fee Ordinance, Attorney Alfieri said DJ Breckenridge, Director of Parks, Recreation and Special Events Coordinator, submitted an email to the Borough Clerk with information requesting a draft ordinance be created for Council's consideration. The draft was sent to DJ and he gave his OK. Administrator Casagrande said that many organizations are holding events that create a lot of trash and it would be best if the organization paid to offset the additional trash cost. The draft ordinance states that a dumpster may be required depending on the event (there are many repeat events at Fair Haven Fields). Mayor Lucarelli agreed with this thought process and making it revenue neutral. This ordinance will be listed for introduction at the April 9th meeting.

With regard to the proposed Tree Ordinance Amendment, Councilman Marchese asked if there would be an increase in the fee to the residents; no. Administrator Casagrande said she had a discussion with Bill Brooks, Borough Forrester, because it is costing the Borough more to administer the program than we are taking in fees. Large construction projects take more time and follow up. Mr. Brooks gave some recommendations for an ordinance amendment. A copy of Rumson's ordinance was provided in Council's packet plus the new State regulations for licensing and certification of landscaper and tree removal companies. Councilman Peters said that he would prefer that larger trees be addressed rather than acting on brush and landscaping of the properties; he is not interested in replacement landscaping. Administrator Casagrande said recently the Borough has been running into issues with trees that will be in the footprint of a new

construction. It is important to look at the current code and make adjustments to address matters. Councilman Peters said that he would work with Councilman Marchese to make amendments since they have history with the process. It is also important to look at the amount of time vs. the costs coming in or the applications where no fee was charged (diseased or dying trees). Councilman Marchese asked that it go on record, as he has done in the past, that he is against telling people what to do with their property. Councilman Rodriguez asked that this matter be referred to Shade Tree for review and discussion at their next meeting. A tree ordinance is needed in order to have a Shade Tree Commission. Our current ordinance will be presented along with Rumson's ordinance for Shade Tree to consider. Councilman Marchese explained that the tree ordinance was once part of the land use section when first enacted. It was eventually amended and placed under the Property Maintenance section of the code.

Administrator Casagrande gave a Bicentennial Hall update as some things have come up over the past few weeks. The governing body discussed this matter at their May 22, 2017 meeting and it was referred to the Recreation Committee (a copy of the minutes was sent to the Mayor and a few Councilmembers last week). This project was started with the Historic Preservation Commission and residents raising funds and then the Borough stepped in. On June 26, 2017, a resolution was passed for a \$35,000 capital expenditure for fixtures. Some items were installed and addressed. Just recently Councilwoman Sorensen and Patricia Drummond (Historic Preservation Commission member and head of fundraising) were at the building looking at the status; the Buildings and Grounds Committee reviewed the status as well. A decision needs to be made on what type of meeting space it should be. Administrator Casagrande said we need to be careful so that there is no high impact activity there. Councilwoman Sorensen said that there is a Historic Preservation meeting tomorrow (3/27) and there is a Recreation Committee meeting at the beginning of next month where this can be discussed. There will not be any potting of plants by the Garden Club, assembling of wreaths by the Scouts or stapling things to the walls. Councilman Rodriguez said that he has been working with Councilmembers Jaeger and Sorensen on a punch list and ideas for usage. Patricia Drummond has some ideas for an opening ceremony. The Borough tried to preserve the historic nature of the building, but some items had to be done in accordance with code such as the ramp, steps, etc. There will be limited bathroom facilities (one bathroom) if someone or a group wanted to hold an event or party, they might have to bring in a port-o-potty. Councilman Peters said he would just like the building to be used.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:43 p.m. Ruth Blaser, River Road, asked what the capacity of the Bicentennial Hall building will be once the project is completed. She was advised that the Fire Marshal will have to make that determination (it is done in tiers depending on whether it is just chairs or chairs and tables). She asked if there would be a functional bathroom and kitchen; yes. She asked if there would be a rain date for the town-wide yard sale; yes, the day after. Mrs. Blaser asked if the No Knock regulations would pertain to Clean Ocean Organizations; yes, it would apply to everyone. She was advised that there are some organizations that are federally exempt from state and local ordinances, but they would still be provided with the list of residents who registered under the No Knock ordinance and asked to respect such a request when they are given their approval to solicit in town. Mrs. Blaser questioned the bill list payment for landscaper stickers; she was advised that tree removal and landscaper companies that register with the Borough are given bumper stickers so they are easier for code enforcement and the police to identify as approved contractors.

There being no further comments or questions, the meeting was closed to the public at 7:46 p.m.

OLD BUSINESS

With regard to the proposed resolution for gun safety legislation, Councilman Peters circulated a memo with a revision which he sent to the Clerk. He read the draft that he had, in full, to the governing body and the public. He advised that he wrote it when he was in Parkland, Florida and he saw the community, memorials, etc. He asked that the resolution, he read, be added to this agenda for action, second by Councilman Rodriguez with Ayes by all present.

With regard to a proposed amendment to the Performance Guarantee Ordinance, Attorney Alfieri sent a draft for Council's consideration. He advised if there were no changes and it was acceptable that the ordinance be listed for introduction on the April 9th agenda and it would then be submitted to the Planning Board for review and comment/recommendation.

Attorney Alfieri sent a draft ordinance to amend the land use ordinance addressing marijuana dispensaries. If there are no changes, the ordinance can be listed on the April 9th agenda for introduction. Councilman Marchese advised he had an issue with the words medical marijuana being in the document. Currently, marijuana is illegal and Councilman Peters asked if the ordinance would be challenged. Attorney Alfieri said that it could not and it would be up to the Land Use board; the ordinance can be modified if marijuana is legalized. Councilman Rodriguez said he reviewed the ordinance in the agenda packet that Rumson created. He felt that the Borough should not make things illegal that are already that way, federally. Medical marijuana is a different matter as long as it is prescribed and supervised. Councilman Rodriguez felt that enacting an ordinance is premature and suggested doing a resolution expressing the Borough's views. Councilman Marchese said Fair Haven was in the forefront and now Little Silver, Middletown, Rumson and Oceanport have come out with ordinances since our initial conversation; we should look into adopting our own ordinance. The consensus of Council was they did not think the ordinance would be challenged. Attorney Alfieri advised the governing body that what is introduced will be sent to the Planning Board. An ordinance will be listed for introduction on April 9th. Councilman Rodriguez said that he would also like the resolution brought back to lobby government. Both an ordinance and resolution can be done. The resolution will be recirculated.

<u>NEW BUSINESS</u> INTRODUCTION OF ORDINANCES

1. Ordinance No. 2018-06, Amend Street Opening Ordinance

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF FAIR HAVEN IN THE COUNTY OF MONMOUTH SUPPLEMENTING CHAPTER 15, <u>STREET</u>, <u>SIDEWALK</u>, <u>CURB</u>, <u>DRIVEWAY AND GUTTER EXCAVATION</u>, BY AMENDING SECTION 1.25, <u>RESTORATION OF THE SURFACE</u>

BE IT ORDAINED by the Council of the Borough of Fair Haven, in the County of Monmouth, in the State of New Jersey, as follows:

T.

The purpose of this Ordinance is to supplement Chapter 15, specifically Section 1.25 Restoration of the Surface.

NOTE: The section of Chapter 15 that is to be supplemented by Ordinance is Section 1.25 <u>Restoration of the Surface.</u> All additions are shown in <u>bold italics with underlines</u>. The deletions are shown as <u>strikeovers in bold italics</u>. Sections of Chapter 15-1.25 that will remain unchanged are shown in normal type.

II.

15-1.25 Restoration of the Surface.

a. 1. Once the excavation work area has been properly saw cut, and the back fill tamped and compacted, the permittee shall install no less than eight (8) inches of bituminous stabilized base course to the trench surface. If the distance from the edge of the excavation work area to the

existing curb is less than two (2) feet, the permittee shall be required to excavate to the curb and evenly install eight (8) inches of bituminous stabilized base course in the entire area.

- 2. The partially restored pavement shall be allowed to settle for no less than ninety (90) days and no more than one hundred eighty (180) days. At the end of the period of time of settlement required by the Superintendent of the Department of Public Works or his designee, an inspection shall be performed by the Superintendent of Public Works or his designee.
- 3. At this time, unless the Superintendent of the Department of Public Works, using a standard of reasonableness, authorizes a less stringent action, the permittee shall be required to mill and restore the excavation work area surface extending from the curb to the centerline of the road or a minimum of one (1) foot beyond the outer edges of the excavation, whichever is greater, and install no less than two (2) inches of FABC surface course. The permittee shall also be required to provide a tack coat on all existing bituminous and concrete surfaces and a hotpoured rubber asphalt joint sealer (per section 908 of DOT Standard Specifications for Roads and Bridges). If the excavation work area will be within two (2) feet or less of a previous excavation made within one (1) year (by the same permittee along the same side of the road), the permittee shall be required to mill and restore between the outermost excavation from the centerline of the roadway to the curb.
- 4. If the distance from the edge of the excavation work area to the existing curb is greater than two (2) feet and less than four (4) feet, permittee shall be required to mill this area, as well as the surface of the excavation work area. In the event that the excavation work area opening is smaller than ten (10) square yards, the Superintendent of the Department of Public Works, or his designee, may determine that milling and/or other trench repair methods be used.
- 5. The permittee will be required to replace any structures including, but not limited to, curb, pavement and sidewalk, that had been undermined by the adjacent trench excavation and restoration work, at his or its expense. Such work shall be performed according to Borough standards.
- 6. Rules and Regulations. Applicant shall comply with all BOCA Codes, Ordinances of the Borough of Fair Haven, resolutions or conditions of the Mayor and Council, or any duly constituted Board and any regulations which the Superintendent of Public Works or the Borough Engineer may establish.
- b. 1. Maintenance Procedures. When final pavement restoration is approved, as required in paragraph a. above, the Superintendent of Public Works or his designee, shall notify the Borough Clerk, in writing, that the portion of the cash repair deposit or performance guarantee pertaining to the street opening permit posted by the permittee at the onset of the project may be released subject to the retainage requested herein below. Such release shall be subject to the permittee agreeing to maintain the restored excavation work area for a period of two (2) years from the date of final approval of the work and posting a maintenance bond to guarantee same. The permittee shall also agree to repair any adjacent structures including but not limited to curb, pavement and sidewalk that are damaged as a result of any excavation work area settlement during this period of time. In furtherance of these agreements, the Borough Clerk shall retain as a cash retainage, fifty (50%) percent of the cash repair deposit and/or performance guarantee during the two (2) year maintenance period.
- 2. If an inspection reveals that the restored excavation work area becomes unacceptable, the Superintendent of the Department of Public Works, or his designee shall notify the permittee that he must repair the area in accordance with the aforementioned procedure within thirty (30) days from the date of notification or sooner if safety on public conveyances is involved. If the permittee fails to repair the trench within this time, the Superintendent of the Department of Public Works, or his designee shall notify the Borough Clerk and he shall allow the Borough to utilize the permittee's cash retainage and maintenance bond to pay for the cost of repairing the excavation work area. If the restoration costs exceed the maintenance bond, the permittee shall be liable for the additional costs.
- 3. Upon the termination of the two (2) year maintenance period, any remaining portion of said maintenance bond that has not been expended shall be returned to the permittee without interest.
- c. The permittee may be required to place a temporary surface over openings made in paved traffic lanes. Except when the permanent replacement pavement is to be replaced before the opening of the cut to traffic, the fill above the bottom of the existing pavement shall be tamped into place, properly graded and topped with a minimum of two (2) inches of bituminous patch material which is suitable to maintain the opening in good condition until permanent restoration

can be made. The crown of the temporary restoration shall not exceed one (1) inch above the adjoining pavement. The permittee shall exercise special care in making such temporary restorations and must maintain such restorations in safe traveling condition until such time as permanent restorations are made. If, in the judgment of the Borough Engineer, it is not expedient to replace the pavement over any cut or excavation made in the street upon completion of the work allowed under such permit by reason of the looseness of the earth or weather conditions or any other reason, he may direct the permittee to lay a temporary pavement of steel plate or other suitable material designated by him over such cut or excavation, to remain until such time as the repair of the original pavement may be properly made.

- d. Acceptance or approval of any excavation work by the Superintendent of the Department of Public Works, his designee, or the Borough Engineer shall not prevent the Borough from asserting a claim against the permittee and his or its surety under the surety bond required hereunder for incomplete or defective work if discovered within twenty-four (24) months from the completion of the excavation work. The presence of a representative of the Department of Public Works or the Borough Engineer during the performance of any excavation work shall not relieve the permittee of its responsibilities hereunder.
 - e. Additional Permit Fee for Excavations on Paved Streets Less than Five (5) Years Old.
- 1. No permit shall be issued by the Superintendent of Public Works of the Borough of Fair Haven which would allow an excavation or opening of a paved or improved street surface less than five (5) years old unless the applicant can clearly demonstrate that public health or safety requires that the proposed work be permitted or unless an emergency condition exists.
- 2. If, by special permission of the Superintendent of Public Works, a permit is issued to open any paved or improved street surface less than five (5) years old, an additional fee shall be charged for the opening, except that the additional fee shall be waived in the event the work is of an emergency nature. The additional fee shall be equal to the sum of three hundred (\$300.00) dollars for the first two (2) years and one hundred fifty (\$150.00) dollars for years three (3) through five (5).
- 3. The Borough Council may, for good cause, allow an excavation or opening of a paved or improved street surface less than five (5) years old, provided that the Borough Engineer approves a restoration plan for the area excavated or opened.

14. Resolution No 2018-84, Advocate for Common Sense Gun Safety Legislation

WHEREAS, the Borough of Fair Haven is saddened by the unthinkable and horrific acts committed at Stoneman Douglas High School on February 14, 2018 impacting the children and broader community forevermore; and

WHEREAS, the Borough of Fair Haven Mayor and the Borough Council as a unified bipartisan body calls for an end to the senseless violence caused by deranged individuals with access to assault weapons in communities around our country through improved legislation at all

levels of government; and

WHEREAS, Children throughout the nation have been negatively affected directly and indirectly by violent crimes involving firearms; and

WHEREAS, Dr. Colleen Kraft, President of the American Academy of Pediatrics (AAP), formally issued a statement on February 15, 2018 on behalf of the AAP that encapsulates our collective sentiment:

"Children are dying from gun violence and Congress is failing to act. Every one of our 100 U.S. senators, and all 435 U.S. representatives bear a responsibility to take meaningful action to protect our children, our families, and our communities. Our elected leaders cannot continue to fail at this most essential task.

We can start by working to advance meaningful legislation that keeps children safe. The American Academy of Pediatrics advocates for stronger state and federal gun laws that protect children, including a ban on assault weapons like the one used in yesterday's school shooting. We also call for stronger background checks, solutions addressing firearm trafficking, and encouraging safe firearm storage. We will also continue to work to ensure that children and their families have access to appropriate mental health services, particularly to address the effects of exposure to violence"; and

WHEREAS, the tragedies of Parkland, Florida, of Newtown, Connecticut, of Columbine High School in Colorado, emphasize the extreme need to immediately address a number of issues including access to firearms, a uniform code of compliance for school security, and the delivery of mental health services; and

WHEREAS, our public reporting systems that are used to identify clear threats, individuals who are in need of mental health services and proactive law enforcement intervention had unacceptable functional gaps. Thus, we need bold actions to improve our reporting of school violence, individuals at risk and public threats. It is unacceptable that these systems which received multiple tips were not up to the task of providing key information to public safety officials who then should have acted with all due haste to address the public risk. The true sadness of this situation was that in the months prior to this incident there appears to have been multiple flags which were raised that could and should have resulted in swift action by public officials and law enforcement that could have prevented this incident and/or saved lives; and

WHEREAS, The Fair Haven Borough Council respects the rights of the vast majority of gun owners who are very aware of the tremendous power of these weapons and who are constantly vigilant in their management and use of firearms. We support the responsible use of firearms in recreation and sports and are confident that the firearms owners and industry can and will work in partnership with our communities to assure that all firearms owners are properly trained and licensed. We also believe that reasonable compromise is the key to both protecting the rights stated in the Constitution of the United States of America as well as assuring that firearms are not in the hands of individuals who lack the control and mental stability to assure public safety. Thus, some aspects of gun regulation must be adjusted to assure that the events at Parkland are not repeated. Our community of Fair Haven demands that the strict assault rifle laws of our State be held as the model for the rest of the nation to ensure these types of atrocities never occur in our community or any community going forward; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Fair Haven in the County of Monmouth, State of New Jersey, urges our national leadership including all members of Congress regardless of party affiliation to identify and implement meaningful action to address access to and ownership of military-style assault rifles, accurate and complete reporting of the activities of at-risk individuals, the delivery of mental health services, and financial support to ensure a safe and secure school climate.
