FAIR HAVEN BOROUGH COUNCIL APRIL 23, 2018

The meeting was called to order by Mayor Lucarelli at 7:04 p.m. The Flag Salute was followed by a Moment of Silent Meditation. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Councilmembers Koch, Marchese, Peters Rodriguez and Sorensen. Absent: Councilman Jaeger. Others present: Administrator Casagrande, CFO Lapp and Attorney Alfieri.

PROCLAMATIONS

The following proclamations were read by Mayor Lucarelli: -Autism Awareness Month (April) -National Bike Month (May) -National Police Week (May 13-19) -National Safe Boating Week (May 19-25)

WORKSHOP SESSION

Mayor Lucarelli said that a street opening denial appeal from 75 Lake Avenue was received to retire gas service. Based on the ordinance that was passed at the last Council Meeting and that the applicant pay the \$150 fee to open a road still under moratorium, a motion was made by Councilwoman Sorensen to approve the appeal, second by Councilwoman Koch with Ayes by all present.

Rumson-Fair Haven Rowing submitted a request to display their oar signs from September 8th until September 23rd. Same request as last year. Motion to approve the request moved by Councilman Peters, second by Councilwoman Sorensen with Ayes by all present.

Councilman Marchese advised that the Board Secretary has been suggesting an increase in escrow fees. A spreadsheet of past cases that were before the board and their payment history was provided to the governing body in their packets. It would be easier to raise the fees than continually having to go back to the applicant for more money. If everyone agrees, the ordinances setting fees would have to be amended. The Borough hired a new Planner this year which may help relieve costs incurred. There is a cost involved for the Planner to flush out the application to keep the process flowing which will mostly apply to zoning matters. Administrator Casagrande said that it is time consuming for the staff to follow up with an applicant requesting additional fees be posted. The costs being discussed pertain to specific applicants/property; it does not affect the rest of the taxpayers. Councilman Rodriguez asked if other towns are having the same issues with escrow. Administrator Casagrande said that most towns review their fees on an ongoing basis. Attorney Alfieri said applicants are always replenishing funds (most pertain to large projects). Councilman Marchese said that it is important to be upfront with the applicant at the beginning of their project. The consensus of Council was to increase the initial escrow fee to \$1,500 and to increase the subdivision and site plan fees. Attorney Alfieri reviewed other escrow fees that may be involved. He will review Rumson and Little Silver's Land Use fees. The Mayor asked that the planner weigh in on fees and then cross reference. This matter will be relisted for discussion on the May 14th agenda.

Administrator Casagrande gave a pond treatment update to the governing body. Treatment at McCarter Pond was a success and the pond was clear last year (chemicals and aerators were added as well as pellets when the temperature was above 60 degrees). This year, \$18,000 was budgeted for treatment of the pond(s). A measuring stick may be installed in the center of McCarter Pond for debris and post treatment. It was recommended that the Borough treat the pond(s) again this year (April to October). With regard to Schwenker's Pond, we would have the same approach for the outside. It was not recommended to treat the pond with pellets because the bottom is sand, not organic material. Administrator Casagrande requested permission to have a Purchase Order cut; the governing body was in favor.

Administrator Casagrande gave a historic district sidewalk update. A Streets and Roads report was provided by Assistant Engineer Poruchynsky. A bricks analysis was given to the Mayor and Councilmembers Peters and Rodriguez a few weeks ago. The sidewalk project is nine years old and there has been movement of the bricks by trees or they have come undone over time. Once a sidewalk is built, it must be maintained. The historic district is not the only area in town with brick sidewalks. It is important to recognize the budgetary constraints to fix them all at once. The Capital Budget items will be reviewed and Council will decide what is approved. Once a budget is struck for the projects, we can review the sidewalks and fix them as we go (most dangerous being priority). The Borough has had a lot more success doing the work

via change order for another project. Councilman Peters will look at the report submitted and review the items. Some areas have not been addressed in quite some time and other areas have been addressed within the last 10 years; spot repairs can be done. Mayor Lucarelli said some municipalities use a saw to cut around the tree to fix the tripping hazard and it allows the tree to grow. It is hard to have a barrier free access requirement especially with Shade Tree status. Councilman Rodriguez said when a brick comes loss, it causes a chain reaction (he has fixed a few bricks down by the dock). Councilman Peters said a lot of street improvements have been done over the last 12 years.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:33 p.m. Steve Knowlton, Church Street, asked if the ponds turned green last year; Schwenkers Pond did (it was not treated) and McCarter Pond. The Environmental Commission is looking a Schwenkers. The disposal of material is most costly, not the treatment. Pellet treatment has shown success and we hope for the same this year.

Ruth Blaser, River Road, said that Bond Ordinance No 2018-12 shows Buildings and Grounds with reconstruction of the DPW, PD, Community Center and Borough Hall. She felt the Bond Ordinance is overbroad and it should not be "pie in the sky" or open ended.

Councilman Peters made a statement regarding the reassessment process. He asked about Resolution No. 2018-106 pertaining to Kolarsick Builders and if the garage issues were addressed and a Certificate of Occupancy was issued; yes, and the house was sold.

There being no further comments or questions, the meeting was closed to the public at 7:37 p.m.

- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.

GOOD OF THE BOROUGH

Mayor Lucarelli opened the meeting to the public for comments or questions at 7:47 p.m. Melissa McCue, William Street, addressed the brush site and truck issues affecting the surrounding neighborhoods. The brush site is not ideal for a residential area. She understood that the site has been there for decades. Since the Borough took on Rumson, the truck traffic has doubled, even tripled. The noise pollution and air pollution with the brush grinding is not good. She said about 3/5 of the brush grinding is Rumson's brush and asked that the hours of operation be 8:30 am to 2:30 pm to control the truck traffic especially when the kids are biking and walking to and from school. There is a great concern for health issues due to the grinding. It was asked if air quality testing has been done to be sure of what could be in the air from this process. Times have changed and public health is important; it was asked that the health aspect be researched as well as the future of public safety. Mayor Lucarelli thanked Ms. McCue for her comments. Since Superstorm Sandy occurred in 2012, Rumson's ILSA for access to the brush site has been significantly reduced and we are looking for an alternate route to access the facility. Our Interlocal Service Agreement with Rumson is linked to other services and not that easy to break. It is a 45-minute run to and from another licensed facility in which the truck(s) burns a lot of diesel and be a lot more, risky to the air quality. The DEP asked us for a list of open land and told the Borough that we cannot do anything with the site and will not allow us to move it on to Ridge Road. The Mayor said he is attending a Mayor's Conference this week and will bring this to the DEP's attention and ask for reconsideration regarding the brush site.

Steve Knowlton, Church Street, asked if the trucks idling is the issue in the neighborhood. It is part of the problem. The trucks sometimes have to wait to be loaded which causes a back-up on the surrounding streets.

Kelly Notine, Hendrickson Place, said she could not attend the last Council Meeting, but submitted a statement. The issue seems to be that the Borough cannot move the site and it is a "money maker". She said it is a safety issue and showed a video to the governing body that she had taken on her phone of the trucks lining up to bring the brush to the site for grinding. Chief McGovern said he spoke with the contractor about arriving early and the gate not being open until a certain time. Mrs. Notine asked that the trucks be re-routed, if they can. She said that she was not aware of the operation before she bought her house. There are small children in the area and these large trucks coming through is a danger. Mayor Lucarelli assured her that the Borough is working on it. Administrator Casagrande said the size of the trucks to be used is in the contract and we reduced the number of months that Rumson can drop off their brush. We are trying to keep the brush grinding to five (5) days and have a Police Officer in attendance. If there are set hours, it will prolong the amount of truck traffic there is as well as the time it takes to grind the brush. The Mayor said some of the debris is storm dependent. The Borough can consider other municipality's philosophy and have brush picked up on once or twice a year.

Ruth Blaser, River Road, said that the Fair Haven Seniors have been in existence for quite some time. A plaque was given to the Borough with Fair Haven Senior Presidents and their terms to be hung. She said that she does not want it downstairs, but upstairs hung in a prominent place. She felt its current location is blocked and disrespectful. She addressed the residents in the area of the brush site saying that something will happen and then the Borough will take action, quickly.

Mr. Knowlton asked for the status of Bicentennial Hall and when it will be open. Administrator Casagrande said that it is a work in progress; close to being finished and hope to open ASAP. The Borough is working diligently with the Historic Preservation Commission on the interior fixtures. Councilwoman Sorensen said the Historic Preservation Commission is working on a reopening ceremony. He asked if the Police Department and DPW buildings were going to be rehabilitated or new buildings built. Larger projects will be discussed in executive session. Mayor Lucarelli said the Council is working diligently on ideas, location(s) and then they will ask for the public's input. We want a solid presentation to execute a plan and then look for input.

Councilwoman Sorensen advised that the Father-Daughter Dance photos are available to be picked up. She thanked the DPW, Recreation Department and Borough Hall for Baseball's Opening Day which took place on April 14th. She thanked everyone who came out and helped clean up the Fair Haven Natural Area; there was a record number of people and a record number of trash cleaned up. The Mayor and Councilmembers Koch and Rodriguez were thanked for helping as well as Travis Manion Foundation for their assistance.

The Fishing Derby and Town Wide Yard Sale will take place on May 5th, the Mother-Son Brunch will take place on May 20th and bulk drop off on May 5th has been extended until 3:00 p.m. because of the town wide yard sale.

Councilman Marchese said the new fence has been installed around the Third Street Ballfield and blends in nicely.

Councilman Rodriguez commented that the Fair Haven Recreation webpage is great. There were a lot of volunteers cleaning up around town for Earth Day this past weekend. The BIC Hall property was cleaned up by the Girl Scouts today.

Administrator Casagrande announced that Recreation now has an Instagram page.

There being no further comments or questions, the meeting was closed to the public at 8:08 p.m.

Council went into executive session at 8:14 p.m. and this meeting was reconvened at 10:22 p.m.

Councilwoman Sorensen said that she received a request from the Fair Haven Business Association to place a banner at the entrance to Fair Haven advertising for Mother's Day Shopping in May. Administrator Casagrande was asked to address the matter.

ADJOURNMENT
