FAIR HAVEN BOROUGH COUNCIL JULY 16, 2018

The meeting was called to order by Council President Peters at 7:00 p.m. The Flag Salute was led by Lily Halpern followed by a Moment of Silent Meditation. Council President Peters asked that everyone keep Officer Dwayne Reevey and his family in their thoughts. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Councilmembers Koch, Marchese, Peters, Rodriguez and Sorensen. Absent: Mayor Lucarelli and Councilman Jaeger. Others present: Administrator Casagrande and Attorney Alfieri.

WORKSHOP SESSION

A request to waive the commercial filming fee was received from Cameron Spector, Cap Gun Productions. He would like to film a short film on Sunday, July 22nd in the Fair Haven Fields Natural Area. He spoke with a received an OK from DJ Breckenridge for use of the area. Councilwoman Sorensen asked where he posts his films? On You Tube and enters them at film festivals, etc. Motion to approve moved by Councilwoman Sorensen, second by Councilman Rodriguez with Ayes by all present.

With regard to Improvements to Third Street, Administrator Casagrande said that the project went out to bid for this project and two bids were received (Earle Asphalt and Diamond Construction) on July 12th; results were at the dais. This project is partially funded by an NJDOT grant (\$200,000). The project will create connectivity to the two schools. In 2016, \$125,000 was allocated to fund the project and in 2017, \$200,000 which totals \$525,000 authorized funding for the project. The base bid is for the actual Third Street work (curbs, sidewalks and realigning a blind spot) and two options; Option #1 was the connectivity piece with sidewalks at McCarter Avenue to the pond, as well as, squaring off the intersection and Option #2 was milling and paving the entire length of Third Street. Diamond Construction was the low bidder for the Base Bid plus Option #1 and Earle was lowest bidder with the base bid and two options. The bids came close to the engineer's estimate. It is up to Mayor and Council on how and when they would like to award the bid. The funding for the base bid portion can be done through ordinances and if it is decided to award all three components, the Borough will need an additional funding authorization. The bid can be awarded at the next meeting or when Council sees fit. Administrator Casagrande said that she spoke with Councilman Jaeger last week and there are two minor subdivisions and a few new homes on Third Street plus the DPW facility upgrade which can be helped with this project. Councilman Marchese agreed that milling and paving needs to be done on Third Street, but there is not a lot of sidewalk traffic. Safe Streets to Schools has kids on their bikes and there are other areas in town where help is needed. Councilwoman Sorensen agreed that other streets need attention.

The meeting was opened to the public for comments or questions on this topic. Robert Lenczyk, Fair Haven Road, said he bought his house because you can fit more cars in the driveway. If sidewalks are installed, driveway space would be lost. He is a 26-year resident and does not recall any injuries occurring on the road that would warrant sidewalks. If both sides of the street have sidewalks, it will be harder to watch the kids.

Consensus of Council was to table this matter until July 30th for further discussion. It was requested that Engineer Gardella attend to speak about the proposed project.

Councilman Rodriguez said the Master Plan calls for this to be done. He read from the resident surveys received. Specifications were prepared and bids were received so the governing body should not back away from the project. Consensus is needed as to what should be awarded.

Lori Marrone, William Street, said that her kids do not attend public school and felt that sidewalks are really important regardless. There are kids in the summer time that play outside, there are cars that speed not to mention the sight obstruction in an area on Third Street. She was advised that the sidewalks would be installed; the question/concern is about the paving.

Administrator Casagrande updated the governing body on the status of 20 Gillespie, LLC. Engineer Gardella received a call from 20 Gillespie, LLC indicating that they would like to meet with him and the neighboring property owner's engineer. The Borough is in the process of calling the bond. 20 Gillespie, LLC would like to use the same contractor for the driveway installations. Attorney Alfieri advised that the Borough has not contacted the bond company because Engineer Gardella is correcting his letter with an update on the project; this will be sent to the bond company. Updated school aid figures were sent on Friday. The Division of Local Government Services forwarded the numbers to the schools and the schools have until Friday, July 20th to amend their A4F statement. The Borough will then prepare and mail out the tax bills.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:22 p.m. Susan O'Brien, River Road, asked when the tax bills will go out. She was advised around July 25th and property owners will have 25 days from the mailing to pay them.

There being no further comments or questions, the meeting was closed to the public at 7:23 p.m.

Ordinance No. 2018-18, Amend Code 3-25, No Smoking in Borough Parks and Buildings

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF FAIR HAVEN IN THE COUNTY OF MONMOUTH AMENDING SECTION 25, <u>NO</u> <u>SMOKING IN PUBLIC PARKS</u> IN CHAPTER 3, <u>POLICE REGULATIONS</u>

BE IT ORDAINED by the Council of the Borough of Fair Haven, in the County of Monmouth, in the State of New Jersey, as follows:

I.

The purpose of this Ordinance is amending Chapter 3, specifically adding Section 25, No Smoking in Public Parks.

NOTE: The section of Chapter 3 that is to be amended by Ordinance is Section 25 <u>No Smoking</u> <u>in Public Parks</u>. All additions are shown in <u>bold italics with underlines</u>. The deletions are shown as <u>strikeovers in bold italics</u>. Sections of Chapter 3-25 that will remain unchanged are shown in normal type.

II.

3-25.1 Smoking Prohibited.

1.

No person shall smoke any products, which include but are not limited to, cigarettes, pipes, cigars, etc. in any municipally owned *building*, public park, sanctuary or recreation area *except on impervious surfaces*.

3-25.2 Violations and Penalties.

For any violation of this Section, the responsible party shall be fined, upon conviction, the sum of twenty-five (\$25.00) dollars for the first offense and fifty (\$50.00) dollars for every offense thereafter, payable to the Borough of Fair Haven.

The deletions are shown as *strikeovers in bold italics*. Sections of Chapter 1.35 that will remain unchanged are shown in normal type.

9-1.35. No Smoking in Public Parks.

No person shall smoke any products, which include but are not limited to, cigarettes, pipes, cigars, etc. in any municipally owned *building*, public park, sanctuary or recreation area-*except on impervious surfaces*.

Council President Peters opened the meeting to the public for comments or questions at 7:28 p.m. Donna Steiner, Colonial Court, asked what the hours are for noise. She was advised that on the weekdays, 8:00 a.m. until dusk and the weekends, 9:00 am until dusk. If there is an issue, she was advised to contact the police department.

Paul Lenskold, McCarter Avenue, asked to address the Council regarding Yacht Works. He received and reviewed information from his submitted OPRA request. There was reference to a 1962 grant and he asked about the agreement and why some documents were not included in the public folder pertaining to the Yacht Works matter. He said there was information referenced in the documents, but he did not have the 1962 grant, January 2017 letter from Tidelands, November 2015 agreement with Yacht Works, a letter from the Borough to the previous Yacht Works owners dated March 26, 1976. Attorney Alfieri advised Mr. Lenskold to OPRA the documents he felt were missing and they would be reviewed to see if they can be released. Mr. Lenskold asked why Attorney Alfieri was filing the lawsuit against Yacht Works and not Mr. Van Dalen, Esq. and if there was a conflict. No conflicts, Mr. Van Dalen's expertise is NJDEP matters and dealing with state agencies. Mr. Lenskold noted \$51,000 in legal fees, to date, and asked if there is a maximum amount budgeted for this matter. He was advised that it is being discussed; this is a property rights dispute where there is an encroachment on borough property (12 slips) which is being illegally occupied. Mr. Lenskold felt there should not be an open checkbook for this matter as taxpayer money is being spent. Attorney Alfieri said there is a budget line item for legal and if it is exceeded, there would need to be a transfer done. It was asked what the total legal line item amount is; Administrator Casagrande said approximately \$85,000 per year is budgeted for legal. He said that there is a 2015 invoice due to Yacht Works that has not been paid; he was advised that it is part of a negotiation agreement. Mr. Lenskold said at the June 25th Council Meeting he asked if Attorney Alfieri was charging the Borough any fees related to the case and that he questioned the legal payment of \$7,888 that he thought was for Mr. Alfieri's law firm. Mr. Alfieri said he must have misunderstood the question/statement and corrected himself by explaining to Mr. Lenskold that the \$7,000 fee was for the other law firm hired by the borough for this matter. Mr. Alfieri stated that his firm began charging for the litigation (Quiet Title) that began in January. It was asked if two law firms are working on matters pertaining to Yacht Works; yes.

Jim Graf, Spruce Drive, felt that Mr. and Mrs. Cerruti (owners of Yacht Works) are being treated unfairly. He stated that they are the hardest working people he knows who have been in business for 50 years. Marinas are the emblem of our town and the Albertina is part of the Borough logo. He asked, "what is going to be gained from this"? Council President Peters said that he will send Mr. Graf and Mr. Lenskold a copy of a picture of the Yacht Works Marina from 1997 and they can compare it to what is there now; if you look at the picture, the difference can be seen. Mr. Graf said that he is concerned as a citizen and a member of Yacht Works.

There being no further comments or questions, the meeting was closed to the public at 7:43 p.m.

Council went into executive session at 7:50 p.m. and this meeting was reconvened at 8:30 p.m.
