FAIR HAVEN BOROUGH COUNCIL NOVEMBER 8, 2018

The meeting was called to order by Mayor Lucarelli at 7:00 p.m. The Flag Salute was followed by a Moment of Silent Meditation. It was asked that the people of California and Pittsburgh be kept in everyone's thoughts. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Mayor Lucarelli, Councilmembers Marchese, Rodriguez and Sorensen. Absent: Councilmembers Jaeger, Koch and Peters. Others present: Administrator Casagrande and Bruce Padula, Esq., Borough Attorney's office.

WORKSHOP SESSION

Mayor Lucarelli advised that there was a request from Rumson-Fair Haven Regional High School asking for permission to have a student art display at various business locations. Administrator Casagrande said there is a concern about the Fair Haven Hardware location; she sent an e-mail to the requestor and spoke with the Mayor about this earlier. The section at Fair Haven Hardware where they would like to display the art (parking lot) is a very busy area with deliveries, traffic coming in and leaving and this might distract drivers. The art can be displayed on the Fair Haven Road side of the building or they can display it at the back of Borough Hall. The businesses are each located in a private building, so they would not need Borough approval. Motion to allow the art to be hung at the back of Borough Hall moved by Councilwoman Sorensen, second by Councilman Marchese with Ayes by all present.

With regard to the 2019 Bulk Schedule, Administrator Casagrande would like to finalize and approve the schedule at the November 26th meeting. A bullet point hand out was provided to the governing body. There was discussion about the Borough DPW handling bulk pick up instead of there being bulk drop off the first Saturday of the month. Zones 1 and 2 would have their bulk picked up the first Monday of the month and Zones 3 and 4 would have their bulk picked up the second Monday of the month which will make it easier for the residents to put their bulk items out over the weekend prior to their pick up. Any appliance will need to be scheduled and paid for (\$15 per appliance) at Borough Hall. There will not be a fee for other bulk items. She explained what items can and cannot be put out. The ordinance will need to be amended for the rules and have the fees removed. The Director of DPW will determine the maximum number of items that can be put out. Administrator Casagrande said that she and the DPW Director determined that the three months where there will not be pick up will be August, November and December. She gave the history of leaf collection from November and December 2017 which was quite a bit. There was discussion about not having pick up two months in a row. Councilwoman Sorensen asked why there will only be bulk pick up nine months out of the year and said she would like to have a pick-up in August. The DPW usually does "catch up" of tasks and prepares for the upcoming school year in August plus there are vacations taken at that time, as well. The consensus of Council was to have bulk pick up January through October with no pick-ups in November and December. This matter will be listed for further discussion on November 26th.

The Annual Best Practices Inventory is due by November 15th. Administrator Casagrande said that the State of New Jersey sends out a Best Practices Inventory with a survey of questions about what is done in the Borough. This year's inventory was much more extensive. The Inventory was answered/prepared, and the Borough received a score of 90% which is great. Part of the requirement is to have the Mayor and Council review the worksheet(s) and we have to report back/certify to the State our answers. Most of the questions were finance and clerk related and Colleen and Allyson did a great job in their responses. Motion to accept the 2018 Best Practices Inventory moved by Councilwoman Sorensen, second by Councilman Rodriguez with Ayes by all present.

Councilwoman Sorensen advised that the Fair Haven Business Association submitted a request for lawn signs and a banner advertising Small Business Saturday (11/24) and the Holiday Stroll and Tree Lighting event (12/7). There will be approximately 30 signs through town and they will be posted 10 days prior to each event. The banner will be installed at the entrance to Fair Haven on River Road coming from Red Bank (same as last year). Motion to approve moved by Councilwoman Sorensen, second by Councilman Marchese with Ayes by all present.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:12 p.m. Susan O'Brien, River Road, asked why the door for Bicentennial Hall was so expensive. Administrator Casagrande said that emergency and panic bars needed to be installed on the doors per code. Mrs. O'Brien asked if the 1st and 2nd Mondays of the month for bulk pick up are going to work; it

is a lot of town to cover. Administrator Casagrande said that it is believed that it will and Rich Gardella, Director of Engineering and Public Works, is comfortable with the schedule. There should not be a high volume of items except in the spring and summer months.

There being no further comments or questions, the meeting was closed to the public at 7:14 p.m.

12. Resolution No. 2018-211, Express Outrage regarding the October 26th killing of 11 Worshippers at Tree of Life * L'Simcha Congregation, Pittsburgh, PA

WHEREAS, on Saturday, October 27, 2018 at Tree of Life * Or L'Simcha Congregation, Pittsburgh, Pennsylvania, a person who expressed his deep hatred of Jews on social media and "wanted all Jews to die," entered the synagogue during regular Sabbath services with firearms and purposefully shot at the worshippers; and

WHEREAS, Pittsburgh police and other public safety officials quickly responded to this outrageous attack, entering the building without regard for their own personal safety, to subdue the attacker, and to otherwise act professionally to ensure the lives and safety of all persons in the building; and

WHEREAS, the attacker killed 11 worshippers and wounded 4 police officers and many other people who were attending the synagogue services in peaceful worship in accordance with their traditions; and

WHEREAS, this reprehensible attack was not only an attack on those innocent victims, but also on all peaceful people of our beloved country, regardless of their religion, race, or national origin; and

WHEREAS, the Anti-Defamation League (ADL) has recently reported that anti-Semitic incidents rose nearly 60% between 2016 and 2017, counting almost 2000 cases nationwide; and,

WHEREAS, there has been anti-Semitic leafletting in certain Monmouth County municipalities in recent months; and

WHEREAS, the Mayor and Council of the Borough of Fair Haven in the County of Monmouth, State of New Jersey, grieves for the victims of this despicable attack, offers condolences to their families, and is united against anti-Semitic and other hate crimes of any kind; and

WHEREAS, the Mayor and Council of the Borough of Fair Haven in the County of Monmouth, State of New Jersey takes this occasion to recognize its heartfelt respect, appreciation and support for the daily work of the Center for Holocaust, Human Rights and Genocide Education at Brookdale Community College ("Chhange") to promote the elimination of racism, anti-Semitism and all forms of prejudice.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Fair Haven in the County of Monmouth, State of New Jersey the offers its heartfelt sympathy, support and encouragement to our county's entire Jewish population, as well as all other persons of any religion, race or national origin, who may be victims of hate or bigotry; and, furthermore, pledges its support for all who believe in the elimination of racism, anti-Semitism and all forms of prejudice.

BE IT FURTHER RESOLVED that the Borough of Fair Haven resolutely affirms that we are all one community and that such heinous attacks on a single group is an attack on us all.

GOOD OF THE BOROUGH

Mayor Lucarelli opened the meeting to the public for comments or questions at 7:21 p.m.

Councilman Rodriguez read a statement regarding the attack on L'Simcha Congregation, Pittsburgh, PA and he thanked Amy Mallet, former Fair Haven resident and Freeholder for bringing the resolution the Board of Chosen Freeholders adopted to our attention. He thanked Al Zager, President of Congregation B'Nai Israel, as well as Mayor Lucarelli and Councilmembers Koch and Marchese for attending the memorial ceremony held on October 29th (as well as Councilmembers Peters and Sorensen who were there in spirit). The resolution adopted this evening is an important step to decrease violence against the Jewish community. Fortunately, New Jersey has some of the toughest gun laws and Governor Murphy signed a bi-partisan bill into law to prevent the manufacture of guns through 3D process. We have a registration requirement for all weapons and training for gun owners. There is a need for awareness of mental health (support health care for mental illness). This morning there was another gun incident this time in Thousand Oaks, CA. Easy access to weapons should be stopped. We need to implore tightened regulations for the safety of our families and neighbors. He quoted Amy Mallet who has said "when one faith is attacked, we are all attacked". Councilman Rodriguez gave his condolences to the Jewish community in Fair Haven and Rumson.

Councilwoman Sorensen reminded everyone that the Veteran's Day ceremony will be held on November 11th at 11 a.m. in Memorial Park. Small Business Saturday will take place on Saturday, November 24th; there will be extended hours to shop and a trolley. She encouraged everyone to support our businesses and shop local. There will be a Menorah lighting held on December 2nd and a tree lighting celebration on December 7th; both at Memorial Park. On November 23rd, Fair Haven will be participating with 7 towns in a rivalry series football game at Count Basie Fields; the proceeds will go to Lunch Break.

Councilman Rodriguez said all Scouts are welcome to come to the Veteran's Day Ceremony; line up will be at 10:45 a.m. to help lead in the Pledge of Allegiance. There will be a Turkey Trot event on Thanksgiving at Fair Haven Fields with a collection by Toys for Tots.

Councilman Marchese said that Rumson-Fair Haven Substance Abuse Alliance will host a multi-media presentation (Hidden in Plain Sight) on December 6th at 7 p.m. in the Rumson Fair-Haven High School Auditorium. The presentation explains how youngsters are hiding drug paraphernalia. He said those who attend will be shocked and "blown away". The annual meeting where Council holds a meeting with Knollwood School Student Government will be held on November 26th at 1 p.m. in the Knollwood School Auditorium. This will be the 10th annual day-time meeting held. He warned everyone to watch for deer on Third Street; they are hanging near the park.

Susan O'Brien, River Road, said there is supposed to be another nor'easter next week and asked if there will be a special brush pick up. Administrator Casagrande said that a DPW crew went out this week to pick up storm debris at the curb (done on a case by case basis). Mrs. O'Brien said she has a pile of debris to be picked up. Councilwoman Sorensen asked that the Borough announce or send out a notification that the Borough will be picking up limbs from the storm that had fallen NOT a full brush pick up.

Meghan Keefe, Beechwood Place, asked for a facility's update and where the Borough is in the process. She was advised that an Architect was hired at a previous meeting and we are waiting for plans to be developed. There is a tentative meeting to be held on January 10, 2019 at Knollwood School to present the proposed plans. Mrs. Keefe asked if there will be plans for the Police Department/Borough Hall. Administrator Casagrande said that the Architect is working on plans for DPW (two options); one to shrink the DPW area at the corner of Third and Allen Streets with equipment housed at that location and another with a parks maintenance facility at Fair Haven Fields. In order to move forward with either plan, there are other procedures that the Borough would need to go through. She asked what is happening with the other moving pieces; we are moving forward with the police department in conjunction with the plans. It was asked if the Borough would be renovating the current Borough Hall building; not at this point, yet. Mayor Lucarelli said that the Borough has been accused of not being transparent; we have been proactive and transparent to get the information out. There will be plenty of opportunity for public comment at future meetings. Mrs. Keefe said that a tax neutral process is being presented, but it seems like dominoes; she asked that the taxpayers be considered and that there be a backup plan in place if the first piece does not work. The Mayor said there are legitimate concerns, but we have our professionals (planners and financial advisors) in place and there is debt rolling off in 2020. He said it is premature to comment on this now until the concept plans and discussions take place. Mrs. Keefe said the Board of Education is working on their 2020 vision and may have a referendum about the schools in town which means there are a lot of pieces in play. Mayor Lucarelli said that he has been working closely with Bennett Coleman, Board of

Education President and Superintendent Sean O'Neil on the silos; he gave a breakdown of where the money goes from the tax bill (state, county, municipal and schools). He said that the Borough always looks at efficiencies to be shared as we always have.

Chris Brenner, Maple Avenue, said that he assumes the Borough is familiar with impervious area. He said he is a fan of the river and the Borough is way over-indexed on impervious material according to the state report provided to Clean Ocean Action. He asked if the rate is considered in all of the projects in town; sidewalk projects are happening and adding to the impervious rate. Mayor Lucarelli said the river is getting healthier with our Environmental Commission addressing it and the Borough looking at our storm water materials. The biggest issue is fecal coliform and fertilizers. A major concession came from Acme when the installed a substantial water system that goes into drywells (tanks). Councilman Marchese said that since the Acme project, the flooding on Colonial Court (a major issue) has ceased.

Art Steinman, Hance Road, asked if the Borough is considering the Sunoco station for a new municipal building. He was advised that the current police department was a school house and does not meet most of the moderate standards such as ADA accessibility, the need for a sally port to handle prisoners. The Department of Corrections inspected our police department and we had some fails. We are in need of a new police station. We also have a ROSI issue; the DEP asked for an open space list from in the 1970s and updates in the 1980s and 1990s. This list took real estate away which then required more real estate. The thought is to have the police department and Borough Hall in one building. Mr. Steinman asked if there were any studies or concerns about the building being located in a high traffic area; the Mayor said the building would be in a walkable/bike able area. There is a need to get the facilities out of neighborhoods. Councilman Rodriguez said the police can actually respond faster being on a main road than going to calls through neighborhoods.

Mike Wiehl, Third Street, questioned the \$6,000 legal bill in the Yacht Works matter and asked when it will settle. The Mayor stated that the matter will continue until it is cleared up.

Cristina Iglesias, Forman Street, asked if there would be a traffic study for the new building and if neighborhood traffic will increase. She felt traffic should be minimized. She was advised that the Sunoco property has been vacant for a very long time. The trip count for a gas station would be more than a municipal building. Administrator Casagrande said the County will require a traffic study since the building would be on a county road.

Nancy Incremona, Spruce Drive, asked if code enforcement was done part time. Administrator Casagrande answered that the police and a part time employee handle code enforcement. Mrs. Incremona asked if she should contact Borough Hall if there is a problem; yes. She questioned clear cutting of properties in town. Mayor Lucarelli said that people purchase property and request to remove trees but cannot clear cut the lot. If trees are removed, they are not significant specimen. Councilman Marchese stated that not all trees are protected by the Borough's tree ordinance. Significant species are not removed unless it goes through the process of Council. There is a requirement to replant trees of a certain species if trees are taken out; "every tree has its day". Mrs. Incremona said she lives in River Oaks and the area has changed significantly; there is not a spruce tree on Spruce Drive.

Evan Hughes, DeNormandie Avenue, congratulated the Council Candidate winners. Mayor Lucarelli thanked him for participating in the process.

There being no further comments or questions, the meeting was closed to the public at 7:54 p.m.

Council went into executive session at 7:56 p.m. and this meeting was reconvened at 8:11 p.m.
