FAIR HAVEN BOROUGH COUNCIL JANUARY 22, 2018

The meeting was called to order by Council President Peters at 7:01 p.m. The Flag Salute was followed by a Moment of Silent Meditation. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Councilmembers Koch, Marchese, Peters and Rodriguez. Absent: Mayor Lucarelli, Councilmembers Jaeger and Sorensen. Others present: Administrator Casagrande and Attorney Alfieri.

OATH OF OFFICE

Attorney Alfieri administered the Oath of Office to Councilman Christopher Rodriguez. His wife, Karen, held the bible while his mother, two daughters and son stood in support.

WORKSHOP SESSION

Council President Peters said the following street opening requests were received from NJ Natural Gas Company:

Motion to approve moved by Councilman Rodriguez, second by Councilwoman Koch with Ayes by all present.

A request from Rumson-Fair Haven Youth Lacrosse was received to post lawn signs (January 23rd to February 28th) advertising registration. Motion to approve moved by Councilman Koch, second by Councilman Rodriguez with Ayes by all present.

A request was received from Fair Haven Education Foundation to hold the 2nd Annual Color Run at Fair Haven Fields on November 4, 2018. There was discussion on the event held in November 2017 with the number of attendees they had compared to the number they are requesting be approved for 2018 (500-800) participants. Chief McGovern said there were no issues to report from last year's event and the additional number of participants should be fine. Fair Haven Education Foundation submitted a report of the event to the governing body and reported the results to the Recreation Committee. Motion to approve moved by Councilman Rodriguez, second by Councilwoman Koch with Ayes by all present.

Councilman Marchese made a request to amend the Borough's Zoning Ordinance to address Smoke Shops and Dispensaries. He is the liaison to the Rumson-Fair Haven Substance Abuse Alliance and they take issue with dispensaries being permitted, especially the legalization of marijuana. Point Pleasant Beach passed an ordinance on this topic; a sample of the ordinance was provided to the governing body in their packet. The consensus was to create a resolution opposing smoke shops/dispensaries and legalizing marijuana for recreational use (not medicinal) that could be sent to Legislative District 13 and Governor Murphy. Chief McGovern agreed with Councilman Marchese that it is important to protect our kids. Councilman Peters suggested listening to what the Governor wants to do and then act on this matter once announced. There was discussion regarding whether to address the matter by resolution or ordinance. The consensus of Council was not in favor of a high-end smoke shop in Fair Haven. Councilman Rodriguez said he did research on both sides of this issue and said that a law should not be passed where something is already illegal. Kids should not be able to get their hands on other drugs, i.e. pain killers, opioids, etc. We need to save lives in town and the high school. There is no bearing if it is for medicinal use. Council President Peters said many people seek opioids, if they are addicted, from their own doctor so we need to be careful. If a legalization law is passed by Governor Murphy, it could be a massive revenue source. The State of New Jersey does not have a large resource for revenue. Councilman Marchese advised that the Rumson-Fair Haven Alliance Program held on January 18th was well attended and a great program. Someone advised him that there are a lot of students vaping during class. Attorney Alfieri was asked to draft a resolution for further discussion at the February 12th Council Meeting under Workshop; the resolution should include the option to opt-out. Councilman Marchese advised that this matter will also affect the zoning ordinance.

Administrator Casagrande advised that Fair Haven received a Stewardship Award from

the NJDEP for our voluntary measures to improve the environment. We were recognized for researching the pollution in the Navesink River and cutting back on water consumption with the rain gardens and rain barrels. We have talented and active volunteers. Council President Peters said the Environmental Commission has filed for a certification. Councilman Marchese advised that Ralph Wyndrum, Environmental Commission Chairman, presented the Environmental Resource Inventory to the Planning Board which will be included with the Master Plan.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:23 p.m. Liz deBeer, Hance Road, said that she worked with students as a former public high school teacher. Kids have been jailed for years and years for distribution (even little amounts). Marijuana is illegal and there is no proof it is a gateway drug. Prescribed pain killers are the gateway drug. She said if it is illegal, it is illegal. Pain killers need to be banned.

There being no further comments or questions, the meeting was closed to the public at 7:26 p.m.

2018 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1 et seq., provides that in preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Borough Council of the Borough of Fair Haven in the County of Monmouth finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and

welfare of the citizens; and

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$64,528.19 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, Borough Council of the Borough of Fair Haven hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Fair Haven, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2018 budget year, the final appropriations of the Borough of Fair Haven shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$225,848.67 and that the CY 2018 municipal budget for the Borough of Fair Haven be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years, and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days of such adoption.

Administrator Casagrande distributed a synopsis memo from Colleen Lapp, CFO, to the governing body. She read it aloud.

WHEREAS, prior to conducting aerial dispensing operations over a designated "congested area", the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and

WHEREAS, the Borough of Fair Haven is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

NOW THEREFORE BE IT RESOLVED as follows:

- 1. The Mayor and Council of the Borough of Fair Haven hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides, by aircraft, for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard or both with the understanding that:
- a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies; and

- c. The County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.
