FAIR HAVEN BOROUGH COUNCIL JULY 15, 2019

The meeting was called to order by Mayor Lucarelli at 7:04 p.m. The Flag Salute was followed by a Moment of Silent Meditation. The Sunshine Law Statement was read.

ROLL CALL

On Roll Call the following were present: Councilmembers Banahan, Koch, Peters, Rice, Rodriguez and Sorensen. Others present: Administrator Casagrande and Attorney Alfieri.

WORKSHOP SESSION

A request was received from Cameron Spector to film on August 10th and 11th on Lake Avenue, Fair Haven Fields and the Fair Haven Road Dock. He requested a waiver of fees. Mr. Spector said that he will be shooting a fun movie in those two days. He has entered his past movies in film fests and contests. He extended an invitation to the shoot. Motion to approve moved by Councilwoman Sorensen, second by Councilman Peters with Ayes by all present.

Administrator Casagrande advised the governing body that our three-year contract with the Garden State Municipal Joint Insurance Fund expires at the end of this year. Since she has a conflict with this matter, Allyson Cinquegrana, Borough Clerk/Assistant Administrator, will work with a subcommittee of the governing body and the Borough's Risk Manager. A subcommittee of the governing body needs to be decided and a resolution of appointment listed on the July 29th agenda. It was decided that Councilmembers Peters, Koch and Rice will be the subcommittee.

With regard to Support Path to Progress Recommendations (NJ Economic and Fiscal Policy Workgroup), Councilmembers Peters and Rodriguez spoke about it and there needs to be a nuanced opinion. Privatization of highways is a concern and challenging since there are no highways except for the Parkway. The Borough and its residents are burdened by paying for it: we should not carry he weight for other parts of the State. Councilwoman Rice was concerned with regionalization of schools. Councilwoman Sorensen agreed; clarity is needed that Fair Haven will not become a County school. We need to hear from our school district. Councilman Peters would like to come back to the July 29th meeting with a statement. Councilman Rodriguez said that the State credit rating is very low and their finances are not in good shape. He also spoke with Councilwoman Koch about benefits and pensions for teachers. This matter will be relisted on the July 29th agenda.

With regard to the FAQ topic discussed at the last meeting, Councilwoman Sorensen said that she and Councilwoman Rice are on the Communications Committee with Administration and the one thought was to incorporate FAQs on the website. Some great topics were received at the last meeting. The first topic will be a facilities update (DPW, Borough Hall and the Police Department). She asked that the meeting be opened for other topics or specific questions for the facilities. Liz MacNeill, Third Street, said that there has been testing at DPW and it would be great to know what is going on. Mike McCue, Third Street, said the status of finalizing the Third Street project. Administrator Casagrande said that the Engineering Department is finishing punch list items now.

With regard to the Borough's website upgrade, Administrator Casagrande said the Borough received quotes and companies were interviewed through the Communications Committee. There is a resolution on this evening's agenda based on a joint recommendation of the Communication Committee to award a three-year contract to CivicPlus.

With regard to the proposed amendment to Ordinance No. 2019-10, Banning Plastic Straws, Styrofoam and Plastic Bags, Attorney Alfieri said that Acme's attorney addressed the ordinance that was introduced at the last meeting and we incorporated those changes. Laline Neff, Environmental Commission, provided some recommendations as well. The redlined changes were distributed to the governing body this evening (a definition was added as well as some exemptions). We can remove some of the language if the governing body wants. Councilwoman Sorensen asked Mrs. Neff if she is looking to not have eggs packaged in cartons. Mrs. Neff said Acme wanted to exclude eggs, meat and produce from Styrofoam; the concern is more for pre-package items not being able to be sold. There is no reason that Acme cannot provide a different kind of tray; they could use more ecofriendly alternatives if they are packaging some things in-house. Administrator Casagrande asked if the governing body wants her to circle back to Acme's attorney with the proposed amendments for their input and relist for discussion on July 29th. The Mayor asked Administrator Casagrande to find out if the Monmouth County Regional Health Commission has a guideline for containers.

The matter of basements and high water will be held for discussion on July 29th.

A request has been made to hold a Jamie Riley Memorial Scholarship Pickleball Fundraiser on October 5th and 6th. Mayor Lucarelli noted many people in attendance for this matter. Sadie who runs the Pickleball events, Cassie Riley (sister of Jamie Riley) and Kim Smith. The fundraiser will be held on October 5th (raindate of October 6th). One tennis court will be left and there will be 12

pickleball courts; tape will be laid down on the court (it will not be striped). The money raised will go toward a Knollwood School Scholarship. All would be honored if the Borough would allow it to proceed. Councilwoman Sorensen asked how the event will be promoted. It will be on Pickleball websites. Beginners and locals are encouraged to come. The event is a fundraiser not a tournament. The hope is to get donations for the winners and for all of the money to go to the scholarship. They were advised to approach the Recreation Committee about this as well. Council-woman Koch said that it would be important that the public be advised that there would not be any tennis that day. Councilwoman Rice asked that the organization reach out to DJ Breckenridge, Director of Parks and Recreation, to have the matter put on the Recreation Committee's August agenda. Councilman Peters made a motion to approve the event, second by Councilwoman Rice with Ayes by all present.
