FAIR HAVEN BOROUGH COUNCIL SEPTEMBER 23, 2019

The meeting was called to order by Council President Peters at 7:04 p.m. The Sunshine Law Statement was read and the Flag Salute was followed by a Moment of Silent Meditation.

ROLL CALL

On Roll Call the following were present: Councilmembers Banahan, Koch, Peters, Rice and Rodriguez. Absent: Councilwoman Sorensen. Others present: Administrator Casagrande and Attorney Alfieri.

Council President Peters read a proclamation thanking and recognizing the Garden Club for the work that they do.

WORKSHOP SESSION

Council President Peters said there was a tree appeal from 88 Parker Avenue. A letter of support from the neighbor on Jackson Street was included as well as photos. There will be replacement trees planted; the property owner will work with the Borough's Forrester regarding type of trees and location. Motion to approve the tree appeal moved by Councilwoman Koch, second by Councilman Rodriguez with Ayes by all present.

Two dates (Tuesday, November 12th or Monday, December 16th) were provided to the Borough by the Fair Haven Board of Education to hold the Annual Marchese Council Meeting at Knollwood School. After brief discussion, a motion to approve that the November 12th meeting will be held at Knollwood School beginning at 1:30 p.m., moved by Councilwoman Koch, second by Councilwoman Rice with Ayes by all present.

The Borough Clerk said at the September 9th Council Meeting, the governing body approved a request from John Carras to display lawn signs in town advertising R+FH Kindness Week (October 7th-14th). He spoke with the Mayor about placing a banner at the entrance to Fair Haven and was given an OK. Motion to approve the additional request moved by Councilman Banahan, second by Councilwoman Koch with Ayes by all present. A resolution will be listed on the next agenda.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:11 p.m. Susan O'Brien, River Road, asked if there were any River Road residents being appointed to the River Road Bike and Pedestrian Safety Committee (Resolution No. 2019-192). Council President Peters said he was not sure and would follow up with the Mayor. The resolution can always be amended if he chooses.

Ruth Blaser, River Road, asked that the resolutions be reviewed line by line instead of voted on as a whole. Council President Peters asked if there was a particular resolution she was concerned about. The Borough Clerk advised that Resolution No. 2019-196 (Executive Session) had two more items added to it this afternoon (under Pending Litigation and Contract Negotiations was added).

Jennifer Spitz, William Street, stated that she saw the resolution awarding the brush grinding, transportation and disposal contract. Council President Peters said that the contract is needed to chip what is existing at the site. Mrs. Spitz asked if there was a time adjustment in the bid; no, the contract is the same as in the past. Council President Peters asked if she preferred a longer day with less hours being worked or less days with more hours being worked. Mrs. Spitz said that her concern is for the kid's safety and the noise, debris and trucks that the residents have to deal with when the operation is in effect. She, personally, would like the work to be done in a shorter amount of time (longer day). She reported that Down to Earth Landscaping is dumping at our brush site from the Fair Haven Fields Buffer Restoration Project and there is a lot of material at the site; they should have to take the debris with them.

Mrs. O'Brien asked if there are police officers in the area during brush grinding; yes, they are there during the operation and escort the trucks through the neighborhood. She said it is important to ensure the children's safety.

There being no further comments or questions, the meeting was closed to the public at 7:21 p.m.
