FAIR HAVEN BOROUGH COUNCIL APRIL 24, 2017

The meeting was called to order by Council President Peters at 7:01 p.m. The Flag Salute was followed by a Moment of Silent Meditation. He read the Sunshine Law Statement.

ROLL CALL

On Roll Call the following were present: Councilmembers Marchese, Peters, Rodriguez and Sorensen. Absent: Councilmembers Jaeger and Wilhelm. Others present: Administrator Casagrande and Bruce Padula, Borough Attorney's Office.

PROCLAMATIONS

Council President Peters read a proclamation for National Bike Month which is the month of May. About two-thirds of the children in town bike or walk to school. We are also working on bike lanes in town.

Councilman Wilhelm arrived to the meeting at 7:04 p.m.

Council President Peters read a proclamation for National Police Week which is the week of May 15th through the 21st. He said that the police see and deal with a lot that they do not speak about. All were encouraged to visit the Police Memorial in Washington, DC; it is shocking to see the number of names on there. The Municipal Clerk advised that Officer John Waltz will be riding in the Unity Tour from Monmouth County to Washington, DC; he will leave on May 9th. This is his 3rd tour.

PRESENTATIONS

Dr. Righi and Frank Gripp of Rumson-Fair Haven Regional High School were invited to the front of the room to give their annual budget presentation. Dr. Righi spoke about student's SAT scores and the school's initiatives. There is a writing program that has been partnered with Rutgers University. One new staff member (Physical Education teacher) is being added to the budget. Class sizes are around 20 students. Enrollment is increasing. Teachers have a flex schedule where some arrive early and leave early and other arrive late and leave later. There will be STEM related field trips. Dr. Righi recognized Chuck Volker and Lourdes Lucas, Board of Education members, who were in the audience.

Frank Gripp provided a handout which will be advertised and on their website. There will be two retirements this year. Money will be taken from Capital Reserves this year. Approximately \$450,000 in State Aid will be received. He advised that 97% of the budget is funded by the taxpayers of Rumson and Fair Haven which is both good (allows more flexibility) and bad (falls on the taxpayer). There will be a 2.99% increase in the tax levy for this budget.

Councilman Jaeger arrived to the meeting at 7:14 p.m.

There are 40 students who attend vocational schools and 15 special education students being sent out of district. Insurance benefits are just under \$3 million of the overall budget; the experience rating is very good. There is a strong focus on student wellness (weight lifting, fitness activities, sports participation) which helps with the rating and prevention of accidents. Maintenance is done in cycles for classes, technology and equipment. There are bids being accepted on April 25th for site improvements to the stadium (to be done in two phases with a total cost of \$400,000). Since there is no longer a vote on the budget by the taxpayers, the high school broadcasts the budget to give everyone an opportunity to hear about it. Information is advertised in the newspapers and on the school's website.

The percentage share is that Fair Haven is increasing slightly to 30.7% and Rumson is 69.3% There are quite a bit of shared services that help benefit everyone.

Sean McNeil and Valery Petrone, Fair Haven Schools, were invited to the front of the room to make their budget presentation. Mr. McNeil recognized Board Members Karen Saad, Bruce Padula and Carol Lang who were in attendance. He said Fair Haven is excited to help the high school with the curriculum and getting students to reach the goals set. They instituted an intervention/innovation program. Some math courses will be changed to fulfill the needs of the students. They are filling kindergarten and ELA program vacancies with reallocated positions for more efficiency. Test scores for the school are not where they expected them to be and adjustments are being made.

Valery Petrone said that Fair Haven relies on the budgeted fund balance for their budget. The budget has a 2% tax levy cap; this information was advertised last week. Insurance costs are at \$200,000 which is not shown in the budget. State Aid has remained flat. She said a bond has been retired so the request for taxes will go down by \$400,000. There will be three retirements this year. About 85% of the budget is contracted (salaries and benefits). There is also a new administration that has come in and they had to justify their budget requests which they did a great job with. Roof top

units will be replaced slowly and the school is on a five year painting cycle. Sidewalks and paving are done, as needed.

Councilman Jaeger asked what the goals for improving test scores are. Mr. McNeil said he would like Fair Haven to be equivalent to Rumson and Little Silver (each are in the 90th percentile). They will start using new strategies and are looking to rewrite the entire curriculum and make changes in teaching strategies. Councilman Rodriguez asked if there was a handle on what was lacking previously (i.e. teaching methods, technology); Mr. McNeil said curriculum. There were holes in what was being taught compared to what was then being assessed. They are working with the high school to meet expectations for the "finish line". Councilwoman Sorensen asked where the school is with the Strategic Planning project. Mr. McNeil said that in the beginning the referendum came up and then strategic planning came into play. Currently, the referendum is on the "back burner", but could be discussed in the near future. Councilman Peters said that the Borough has offered to work with the school on a lease for \$1.00 for Willow Street property to help with spatial issues. Today there was an Asbury Park Press article about Lakewood stating that a solution to their finances is more State Aid; he said we need to change funding formulas at the State level. The school boards were thanked for their presentations.

Councilman Wilhelm left the meeting at 7:39 p.m. and returned at 7:41 p.m.

WORKSHOP SESSION

Council President Peters said there is a lawn sign request from Fair Haven Girls Lacrosse Camp to post them from May 1st to June 1st at Fair Haven Fields. Motion to approve moved by Councilwoman Sorensen, second by Councilman Rodriguez with Ayes by all present.

With regard to a proposed amendment for medical and dental office parking requirements, Councilman Marchese advised that he was approached by the Fair Haven Business Association and he recommended moving forward with the draft ordinance prepared for introduction on May 8th. Medical and dental offices will then become part of the professional category. The consensus of Council was to introduce the ordinance at this meeting.

The Jersey Shore Youth Rugby Association submitted a lawn sign request for their spring sign-ups for one month through town. Motion to approve moved by Councilwoman Sorensen, second by Councilman Peters with Ayes by all present.

With regard to amending Chapter 30-7.8, Accessory Buildings and Structures, Councilmembers Marchese and Peters will send Attorney Alfieri something to be considered at the May 8th meeting.

PUBLIC COMMENT ON AGENDA ITEMS

The meeting was opened to the public for comments or questions at 7:45 p.m. Chris Brenner, Maple Avenue, said that Yacht Works has been listed as possible litigation for quite a few meetings. He asked why and if the information will be public once it has been resolved. He was advised there is a document available at the DEP. Administrator Casagrande said that the Mayor and Council have been discussing a matter that was brought to their attention; as there are updates, it is discussed in Executive Session. He asked if there is a time frame for information to be released; no. Councilman Wilhelm said that we are acting on the taxpayers behalf. Mr. Brenner asked if funds are being spent on this? Yes, the bills are public record.

Ruth Blaser, River Road, questioned the bill for testing of officers; as part of the promotion process, there was testing and interviews. We have five police officers who are going through the process. She asked about the bill for the garage door at the Concession Stand; an electric door needed repair. She asked about the extension of the RDS contract for revaluation inspections. Councilman Peters said that we are required to have a tax inspection process through the County and State Tax Board. We are extending the contract for an additional year which is allowable under the current agreement we have. Mrs. Blaser asked what a duplicate Tax Sale Certificate is; Administrator Casagrande said that someone has to produce the original certificate to redeem the tax sale. She asked what property it is for; 259 Third Street. She asked about the award of contract for irrigation services and how long it is for; it is to water Borough properties and expires in one year.

Susan O'Brien, River Road, questioned the bond reduction for 20 Gillespie and why it is being done. She was advised that the developer can make a request to reduce their bond based on the work that has been done to date. Engineer Gardella received the request, made his inspection and gave recommendation.

There being no further comments or questions, the meeting was closed to the public at 7:41 p.m.

Administrator Casagrande explained the budget, debt service, notes, etc. There is an 11% increase in health benefits due to change in family statuses (marriage, children). We received \$405,000 from a sale of Borough property which is included in this budget as revenue.

There being no further comments or questions, the hearing was closed to the public at 7:56 p.m. on motion of Councilwoman Sorensen, second by Councilman Jaeger with Ayes by all present.

In computing the number of required parking spaces, the following shall apply:

- (1) Where fractional spaces result, the required number shall be construed to be the next highest whole number.

- (3) If there is not use enumerated herein having sufficient similarity to the use proposed to enable the Municipal Agency to establish rational parking requirements, the Municipal Agency may, in its discretion, direct the applicant to furnish the Municipal Agency with such data as may be necessary to enable the Municipal Agency to establish rational parking requirements.

** Bar, restaurant, or similar uses shall be calculated separately.

*** A building of mixed office uses may include a maximum of one-third (1/3) medical or dental floor area. If medical or dental uses exceed one-third (1/3) of the gross floor area, their parking requirement shall be computed separately.
