The meeting was called to order by Mayor Lucarelli at 7:04 p.m. The Flag Salute was led by Chief McGovern and followed by a Moment of Silent Meditation. The following Sunshine Law Statement was read:

WORKSHOP SESSION

Mayor Lucarelli advised there was a request from Knights of Columbus to post a few lawn signs advertising their March 15th Blood Drive.

Motion to approve moved by Councilwoman Koch, second by Councilman Banahan with Ayes by all present.

The next matter discussed was the Girl Scouts who would like to plant trees. Elisa Bertocci, a troop leader, said that an e-blast was sent out from the Borough regarding trees that she had seen and has been working with Councilwoman Neff, the Fair Haven Natural Area Committee and Shade Tree. The project would be for the 7 troops that are in Fair Haven to each purchase a tree (Blue Spruce or Oak, 5'-6' high for the Ridge Road area) to be planted. They have also reached out to the Fair Haven Board of Education to see if there are any areas on school property where planting would be needed. Another idea was to coordinate with Rumson's Girl Scouts to do something, mutually, on Arbor Day. The trees will be planted to last and to help provide a sense of community. Councilwoman Neff said that this project is part of the Girl Scout Tree Promise and is an exciting project. She has spoken with Council and other Borough leaders and it seems that the Natural Fields Area would be the best place to plant for logistic and maintenance reasons. The schools may be interested in a few of the trees. Discussions will take place with the Natural Area Advisory Committee for the best locations. Blue Spruce and Oaks are long living trees. Councilman Banahan said that this is a great project.

The meeting was opened to the public for comments or questions at 7:17 p.m. Robert Marchese, former Councilman, thanked the Mayor and Council, Administrator Casagrande and Allyson Cinquegrana for supporting the proclamation for Toxic Shock Syndrome Awareness; they are a ProBono client of his. This is an important topic and something that is preventable. He and his client, the Massabni Family, appreciate the support.

Jordan Grace Robinson, "Don't Shock Me" Maddi Massabni Foundation for Toxic Shock Awareness Public Relations Chairperson, read a statement from the parents of Maddi Massabni. They requested permission for the posting of a TSS preventative brochure on the Borough website and Facebook page with information of Maddi's life, prior to her passing, to help educate the public on Toxic Shock Syndrome. She read an article that was posted by TapInto Middletown. Details of a fashion show fundraiser will be forthcoming.

Attorney Cannon said that the ordinance would need to be reintroduced; he suggested adopting this current ordinance and any amendments could be introduced in another ordinance with the same timeline. The Clerk advised that if the actual salary were being amended then the salary resolution would need to be amended, as well. Councilwoman Chrisner-Keefe asked Councilman McCue if there were any other ranges he was requesting be changed; no.

NEW BUSINESS

Council Committee Reports

Finance - Councilman Banahan reported the Borough's financial status is the same; finances are at healthy levels. He noted two resolutions (81 and 82) under resolutions to be considered. Tax Collection also remains strong.

Personnel - Councilwoman Chrisner-Keefe did not have any personnel updates.

Planning & Zoning - Councilwoman Koch reported the Zoning Board met on March 4th with three applications on the agenda; two were carried forward. There is a backlog of cases for the Zoning Board so there may be some extra meetings held to assist with moving applications forward. The Planning Board meeting will be held on March 16th; the facilities plan will go before the Board for capital review. Administrator Casagrande said the Architect sent a copy of the plans which will go to the board. Advance copies were sent to Engineer Gardella and Chairman Lehder for review, and they will be posted on the website for the public to view. Councilwoman Koch thanked Judy Fuller for her assistance during the vacancy in the position of Secretary to the Planning Board and Zoning Board. She welcomed Sandra Papa who is the new secretary to the Boards.

Parks and Recreation and Communications - Councilwoman Koch advised that spring camp registrations are underway and are posted on the Recreation portion of the website. She reminded everyone to vote for the talent show; see the Borough's Facebook page for more information. Shared Service with Board of Education for the turf area at McCarter Park will be acted on under resolutions tonight.

With regard to communications, the Borough staff and Library staff are helping seniors with COVID vaccination registration.

Police, Fire & OEM - Councilman McCue advised that our COVID numbers are going down (51 active cases).

Engineering, DPW and Borough Facilities - Councilman Rodriguez reported that the Facilities Committee met last week with the Green Team who provided ideas and contributed information for the police department and DPW site plans that would make the plans more efficient and environmentally friendly. There is potential grant money for their ideas. The capital review will be done next week at the Planning Board where the public can get a sneak peek at the plans. There are no other updates.

The Brush Committee met last week and will work on a memo with recommendations for the brush site.

WHEREAS, The Goldstein Partnership ("Architect"), a licensed architect in the State of New Jersey, was retained by the Borough of Fair Haven (the "Borough") to perform preliminary architectural services by way of Contracts for Professional Services, dated December 11, 2017,

October 9, 2018, and February 12, 2020, for the anticipated construction of the Borough's new Police Department and Public Works buildings (the "Project"); and

WHEREAS, the Architect previously submitted two (2) Proposals to the Borough to perform design, bidding, and construction administration services in connection with the Project, which Proposals were approved by the Borough's Mayor & Council by Resolution No. 2021-51, dated February 10, 2021, and by Resolution No. 2021-66, dated February 22, 2021; and

WHEREAS, based upon the foregoing Proposals, the Architect and the Borough have negotiated and prepared a Contract for Professional Architectural Services, which is attached hereto as Exhibit A, to memorialize the terms and conditions of the retention of the Architect by the Borough for the Project; and

WHEREAS, the Architect has submitted to the Borough all required forms and documents in compliance with the New Jersey Local Public Contracts Law and the New Jersey Pay-to-Play Law; and

WHEREAS, the Borough has bonded for the Project and will encumber funds to pay the Architect for the professional services provided to the Borough under the Contract for Professional Architectural Services attached hereto as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Fair Haven, County of Monmouth, State of New Jersey, hereby:

- (1) Authorize the Mayor to execute the Contract for Professional Architectural Services attached hereto as Exhibit A; and
- (2) Direct that a certified copy of this Resolution be forwarded to the Borough Administrator, Chief Financial Officer, Borough Engineer, and The Goldstein Partnership; and

BE IT FURTHER RESOLVED that the Borough Administrator is hereby authorized to prepare the appropriate purchase order(s) for the invoices received from the Architect under Contract for Professional Architectural Services attached hereto as Exhibit A, and to draw down from those encumbered funds, inclusive of work performed to date on the Project; and

BE IT FURTHER RESOLVED that the necessary funds to pay the Architect under Contract for Professional Architectural Services attached hereto as Exhibit A will be encumbered from existing bonds obtained by the Borough and payment to the Architect will be made through purchase orders as services are provided.

Councilwoman Chrisner-Keefe asked for a point of discussion. There have been inquiries from members of the public regarding the exhibits that were not available for review (PD and DPW); i.e. questions regarding the financials. There were a few revisions to the Police Department proposal as well as a separate proposal for the DPW site. The Architect proposal for the DPW building is \$192,580 plus \$10,000 for reimbursable expenses. The Police Department proposal is for \$291,400 plus \$11,000 in reimbursable expenses. Attorney Cannon reviewed the quotes/proposals, made edits and finalized it with the Architect. Administrator Casagrande advised that anything already paid was credited to us. Attorney Cannon said the subcontractor had a 10% increase in their proposal and we had it withdrawn. Councilwoman Chrisner-Keefe asked Councilman Rodriguez for any input as far as the facilities. Councilman Rodriguez stated that all committee members reviewed the proposals and they appeared to be in order. He thanked Attorney Cannon for his review and involvement.

Councilman McCue asked if there were other documents and cited references that are missing in the information that was provided. Attorney Cannon said that most references are Architect related and how they are going to make the buildings green; he explained why it is referenced and how it will tie into the actual design. These matters will be addressed when the Architect is charged with the buildings becoming green, certain standards and how it will be done. Councilman Rodriguez said Eli Goldstein, Architect, could provide examples/samples of work he has done in Maplewood and other municipalities with green objectives. Attorney Cannon said there will be the option of multiple bid packages and options when going to bid.

Tracy Cole, Grange Avenue, would have liked to see the exhibits on the website with the agenda and asked that it be considered by adding them to the agenda packet. She had questions about the scope of the proposed buildings and if it takes us to the construction phase; yes, it is inclusive of construction to close out. She stated she is aware of Eli Goldstein's credentials and he is well regarded. She asked if the scope of work is for both DPW and the Police Department? Yes.

Mayor Lucarelli said that he and Administrator Casagrande were on a call Friday with Senator O'Scanlon and Assemblywoman DiMaso who are working with the VNA to compile a list and assist with COVID vaccinations. Administrator Casagrande said it was a very productive call. Not only are they partnering with the VNA, but also with Meridian. We will coordinate with other municipalities, so we are all on the same page. There will be press releases on this information and we will post updates, etc. Fair Haven has already started pairing seniors with volunteers to help with registrations. We look forward to working with Senator O'Scanlon and Assemblywoman DiMaso and our neighboring towns.

Councilman Rodriguez commended and congratulated all of the walkers in the walking challenge for the hundreds and thousands of steps and their participation. It is great to see so many walking through town and taking in the fresh air. There are still a few weeks left. Kate Raftery, Environmental Commission's Green Team, advised that we will also be receiving some green credits for running these types of programs in town.

Councilwoman Chrisner-Keefe wished all of the ladies a "Happy International Women's Day". She thanked those ladies who have run and serve stating that it is a pleasure serving with them. She felt it was appropriate that the Toxic Shock Syndrome Proclamation was read on Women's Day; it is an extremely important topic that many are not aware of the symptoms and what to look out for. She thanked the Mayor for reading it.

Mrs. Blaser said that she is also impressed with Eli Goldstein's credentials and hopes he provides every inch of space for use by the public such as incorporating Wifi access and warming/cooling spaces.
