



## Dog and Cat Registration 2024

All dogs aged six months or older and all cats aged seven months or older (or with permanent teeth) must be licensed annually. All dog and cat licenses expired December 31, 2023 and must be renewed for 2024.

**The 2024 fee schedule is:**

Dog Neutered/Spayed	\$15	Cat Neutered/Spayed	\$10
Dog Unneutered/Unspayed	\$20	Cat Unneutered/Unspayed	\$15

Certification from a veterinarian indicating your animal was neutered/spayed must be submitted with the application unless previously provided. Please note that in order to renew or obtain a new license, your cat(s) or dog(s) must have a current rabies vaccination. Rabies vaccinations must be renewed for 2024 if the vaccination expires prior to November 1, 2024. Rabies vaccinations are effective for one year for cats and dogs vaccinated the first time. For subsequent vaccinations, a three year period applies. Unless vaccinated at the Fair Haven Rabies Clinic, a Certification of Rabies Vaccination from a veterinarian must accompany your license application. The only exception is in cases where the vaccination is still effective and a Certification of Rabies Vaccination has been previously submitted during the current vaccination period.

## **Borough Ordinances Regarding Dogs and Cats**

Kindly note that several Borough Ordinances relate to supervision of dogs and cats including:

Any dog off its premises must be accompanied by a person and controlled by an adequate leash not more than six feet long. (Ord. 5-3.2)

The owner of any dog shall be responsible for any damage done by that dog. (Ord. 5-3.3)

Pet owners and keepers are required to immediately and properly dispose of their pet's solid waste deposited on any property, public or private, that they do not own or possess. Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$100.00. (Ord. 5-15.3)
