Improvements to Hance Road and Cooney Terrace – Phase II

As you are aware, the governing body has a special meeting scheduled for this evening for purposes of revisiting the resolution to authorize bid of the above referenced project. It should be noted that the final design and construction needs to substantially meet the scope of work as outlined in the NJDOT Municipal Aid grant. Based on review of the proposed resolution (2021-331) and current proposal, the following should be considered:

- Both roadways need to be designed to ensure proper grading and drainage.
- Both roadways will be milled and paved.
- Portions of the existing curb (concrete and asphalt) are deteriorated and need to be replaced.
- Certain driveways/driveway aprons need to be reconstructed to ensure proper drainage.
- Minimal sections of new curbing need to be installed to eliminate erosion at the existing edge of pavement.
- All catch basins and sections of pipe need to be replaced, including installation of bicycle safe grate and eco-heads (curb pieces).
- A portion of Hance Road (in vicinity of #18, #20, #26, and #32) will be straightened and realigned resulting in a cartway width of 22 feet.
- Curb with proper radius will be installed at all intersections.
- Utility poles will be relocated, as appropriate.
- Perform a study to reduce speed limit to 20 MPH in coordination with the Chief of Police.
- Consult with an arborist regarding tree removal and performing work within close proximity of existing trees.
